#### TUESDAY, 10 SEPTEMBER 2019

- 1 The House met at Ten o'clock a.m.
- 2 ACKNOWLEDGEMENT OF TRADITIONAL PEOPLE. The Speaker made a statement acknowledging the traditional people of the land.
- 3 PRAYERS AND REFLECTION. The Speaker read Prayers.
- 4 DISTINGUISHED VISITORS. The Speaker said "I welcome to the Chamber the Speaker of the Legislative Assembly of Western Australia, Hon Peter Watson MLA, and the Sergeant-at-Arms, Dr Isla Macphail."
- 5 STATEMENT BY SPEAKER. The Speaker made the following statement:

"Last week, the Leader of the Opposition made public statements that were clearly a reflection on the role of the Speaker. Any reflection on the character or actions of the Speaker inside or outside the House is highly disorderly. A fundamental tenet of parliamentary practice is that any Speaker's actions may only be criticised by a substantive motion moved in the House. I ask that all Members of this House think carefully about using the role of the Speaker to make their political points and ask them to also reflect carefully on the code of conduct that all members of the Tasmanian Parliament have signed.

This states that a Member must observe proper standards of parliamentary conduct by complying with the Standing Orders and the directions of the Presiding Officer. There is a range of options available to me in my role as Speaker. I have determined to not take those options but instead have written to the Leader of the Opposition and have asked her, consistent with precedent, to withdraw her comments at the first available opportunity today and to apologise for them.

I ask that the Leader of the Opposition now do so, so that the matter can be concluded without any unnecessary escalation and the House returns to its business."

And the Honourable Member for Lyons, Ms White, withdrew the comments referred to.
