1 COUNCIL MEETS.— The Council met at 11.00 o'clock in the forenoon and the President read Prayers.

2 **PAPERS.**— The Clerk of the Council laid upon the Table the following Papers:—

- (2) Land Acquisition Act 1993: Notice of Acquisition of land under Section 18. All that part of the land formerly within certificate of Title Volume 110771 Folio 20 containing approximately 1.236 m2 situated in West Hobart in Tasmania and now contained within certificate of Title Volume 177119/Folio 1.
