- 2 ACKNOWLEDGEMENT OF TRADITIONAL PEOPLE. The Speaker made a statement acknowledging the traditional people of the land.
- 3 PRAYERS AND REFLECTION. The Speaker read Prayers.
- 4 STATEMENT BY SPEAKER. The Speaker made the following statement:

"I wish to address the events which occurred in this House during the Adjournment Debate last Thursday, 20 August.

First and foremost, as Speaker, I acknowledge that it is my task is to protect the rights of all individuals in the House and make sure that everyone is treated fairly within the framework set by the Standing Orders.

It is my role to maintain such order during debate and, while most proceedings pass routinely and without incident there are occasions when passions become inflamed, excessive interjection occurs, and the House becomes noisy and unruly.

The Standing Orders provide disciplinary powers to enable me to maintain order. As you are all well aware, these vary in their severity and allow me to deal with breaches of order in the most appropriate manner. Having been in this House for just over two years, I am continuing to learn the practical application of these standing orders in all situations.

Last week an individual Member was concerned that her contribution was interrupted without due reason.

I would like to reassure this House that it is my commitment to ensure the foundations of the Westminster Parliament are upheld and that individual members can rightly contribute in line with the rules and forms of the House.

For any grievances that may arise in future, can I encourage Members to please raise them directly with me.

I reiterate that I wish to see this House to be a safe workplace with the Members showing relevant respect to each other, and more orderly behaviour as the public expect of us all, as role models."
