attached is a letter of a few brief  
 listings with a copy of the C.D. P.D.F.  
 of my book called "The Process to Liars,  
 Thieves and the Truth" now with the  
 Publisher in Melbourne, Victoria,  
 Animals Australia, and in London, England,  
 as I am a legal citizen of the  
 Commonwealth. Evidence on the Greyhounds.

1. Having the names on the Committee  
 Mr Bacon would be Conflict of Interest.
2. Case - 40 plus Greyhounds. charges  
 laid stated, "A number of", How many  
 is a number of?
3. Front page of Examiner newspaper  
 12/11/99, a raid on 11/11/99. Two  
 legal instructions given under TATI,  
 majority of dogs registered, young, 6 months  
 to 13 months. Twenty-five left.
4. The two dogs in case part of 25 dogs,  
 arrived at Boland St in June 99.
5. Dianne Burkhalter and myself  
 brought about the charges and  
 conviction. Last day 11/5/2000.

6. Two dogs collected at Boland St, VKC148/VKC150, to be in-case at Elspedito Enterprises at Glengarry, at no time was I ever informed of any raid on these two dogs, part of 25 dogs remaining. Mr A. Reid's name and address omitted from newspaper on 12/11/99.
7. The premises at Boland St, Launceston where the raid took place, was owned by St. John's Anglican Church.
8. The property at Glenmore Estate, Glengarry in 1990 was owned, I believe, by Mr Grey. In 1991 late, a Mr Fred and Esfriede Chan purchased the property. All the developments in 1990, tribunals, Court attendances, etc were instigated, and in the name of Salina Chan their daughter, as at the same time, the parents were trying to have the same development at Los Angeles Rd, Dilston. Launceston Council denied the whole development. Salina Chan and her parents lived at No 4 Blanco Ave, Mania, Sydney.
9. Both Salina Chan, Mr A. Reid, Mr Fred and Esfriede Chan did NOT have a kennel license, which came under the Dog Control Act of 1987, the liability of the Governor of Tasmania, now the Dog Control Bill 2001, with the Premier, Premier and Cabinet.
10. Salina Chan did not have permission from the titleowner. Did Mr A. Reid have permission? Case against Mr A. Reid December 2000.

11. The conflict of interest in this case to me:
- (a) Jehovah Witnesses,
  - (b) Mormons,
  - (c) I believe both (a) & (b) connected to Freemasons - masonic lodge. Documentation to stalking, abuse, events.
12. Elspedito Enterprises the only pet boarding business to have dogs from this case.
13. My F.O.I.'s refused by Mr J. Ellis, the Director of Public Prosecutions, the case was done by D.P.P. The Ombudsman many times, m/s Jan O'Grady had to enforce my F.O.I.'s, which many I still do not have. Their defence in Court on me was "Scandalous, frivolous, Oppressive".
14. The D.P.P. were more concerned about Mr A. Reid and his nephew, than the dogs, myself and small business. Mr Jim Ellis in writing to me stated, "I would be best to drop this matter and get on with my life", to that effect.
15. I was very sick, and had an appointment with Superintendent Ivan Dean. Dianne Burkhalter on my behalf gave Mr Ivan Dean the documentation, and stated to her to go to the Ombudsman as it has nothing to do with Police. FACT OF LAW All Police Officers are Officers under the Animal Welfare Act 1993.

15. Mr A. Reid known by Authorities since 1985, cruelty.
16. I had to prove in the Court, Launceston that I was not born with a mental condition. I did from 5 years old to near 16 years old. My kennels and house were claimed to be dirty, accepted by a government Authority handed up. A nightmare for the business and myself.
17. It took years for decisions. In the book.
18. Refused F.O.I's from Governor-In-Council, given the Governor under an Act of Parliament for kennel licences. The request letter of 2008, still refused the F.O.I's., no answer to why.
19. I was not informed of D.P.P changing Solicitors to Douglas and Collins, which would have been Conflict of Interest.  
The Court tape, letter attached 4-5-2015. Persons were telling magistrate Wilson what they wanted and how it was going to take. I was not late for the Court, I was not in the Court room. When I was called in, there were 3 men, 1 woman. From the start to finish the timing was exact. I was trying to obtain the two dogs int care fees VKC 148, VKC 150, which I was entitled under the law. The abuse was horrific. The yelling at me by magistrate Wilson, I was chopped off trying to explain. I was without a solicitor. I certainly received no assistance.

20. Mr A. Reid committed same with greyhounds April 2002.
21. I went to apply to three Solicitors in Devonport for pro bono work to help me. Two sent back within 48 hours could not assist. The third one a Mr Richardson, I was informed to go to had documentation for 6 weeks, then returned stating could not help. When I received my F.O.I's from the Racing Industry, the time Mr Richardson was helping Mr A. Reid with the Racing Industry. I complained to the Law Society, nothing wrong. Not long after Mr Richardson in quite a feature article, a criminal lawyer, and owned and raced 13 greyhounds.
22. What cruelty went on at Epping Forest by Mr A. Reid?
23. How many dogs in<sup>no 22</sup>? Was any vet involved in all this cruelty?
24. Were the greyhounds used for dog fighting? The injuries on the male dog in-care, when bathed and examined, on video and photos, were not good. I had to have a Chiropractor to both dogs. He is well known in the Racing Industry in Victoria and Tasmania.

25. I was with the two dogs when they died.
26. My mother used to visit 2-3 months of the year, who lived in Maroubra, Sydney. My mother was being harassed, she received a broken arm, black eye. Two mormons appeared at her door and told her they would be back. She had a massive heart attack. Not my mother nor members of my family knew what a mormon was. My mother was after 40 years there was taken to Brisbane where she died.
27. Three times I met with Minister Blewett.
28. The Premier and magistrate H. Woods were notified in writing of my financial position and Australian Debt Insolvency was involved.
29. The Premier believed Dally Shepherd against the Ombudsman and the documents handed up. The same applied to Minister B. Gleeson.
30. My representative was given the documentation Mr. Harry Finch who had his adviser with him, and after a certain amount of time, with no consultation during that time, walked into my premises holding a box and in front of a client handed over the box stating, "to listen to what was being said", and walked off. The case.

31. On trying to obtain two paragraphs on a two page advice, required from Local Government, denied under S29 of the Freedom from Information Act 1991, written by Mr Simon Alston in the Solicitor General's Office, I also applied when he was the Ombudsman. Denied.
32. On 22/6/2001 Minister Llewellyn writes to the owner of the two dogs. Does not inform Mr J. Borg who was a Steward in the Racing Industry (I was informed) of no trial, no evidence, no 14(1). Blamed me. I received phone calls from Robert 6-30pm as I refused to sign defective registration papers to ownership, to Minister Llewellyn, when I met, he told "you gotta sign these papers".
33. R S P C A Inspectors are appointed by the Minister, paid by the Crown under D.P.I.W.E.
34. On tape as stated in the Court was the incident with Police Officer Mr Summersville and Mr Ricky Shogog who was, I believe, dismissed from the police force, now a Councillor.
35. My architectural kennel plans were given to two boarding facilities.
36. The documents on C.D.. The dogs received a single bullet to the head leaving the two I had, EVIDENCE.

37. The majority of the dogs were Victorian. I went to the Attorney General also the racing industry Mr R. Hull, with documentation for assistance. What a joke.
38. I went to the various Racing bodies to find the owner of the two dogs. I was informed their mother was very fast. The two dogs in-care were very flexible and did not have hard pad even running at times on gravel.
39. The threats on my life and to kill the dogs, was stressfull for years. The harassment. I had clients, who I never discussed the case with, told me no 14(1) was given. This is an island.
40. If this Committee requests to view the kennels, on appointments, I am happy to. They are the 1st kennels set up for pet boarding designed for dogs, 1947.
41. The last four page of the book are from the feature in the Mercury newspaper dated 24-12-2011.
42. I am not willing to relive anymore. I will always see one face, 7 months old, I tried to get out, got the bullet.
