- 2 ACKNOWLEDGEMENT OF TRADITIONAL PEOPLE. The Speaker made a statement acknowledging the traditional people of the land.
- 3 PRAYERS AND REFLECTION. The Speaker read Prayers.
- 4 LEAVE TO MAKE MOTION WITHOUT NOTICE. *Ordered*, That Mr *Winter* have leave to make a Motion without notice for the purpose of moving the suspension of Standing Orders to enable Notice of Motion No. 145 from being moved forthwith. (Mr *Winter*)
- 5 SUSPENSION OF STANDING ORDERS. *Ordered* A Motion being made and the Question being proposed—That so much of Standing Orders be suspended as would prevent the Motion from being debated forthwith. (Mr *Winter*)
- **6** WANT OF CONFIDENCE IN THE PREMIER. A Motion being made and the Question being proposed—That the House:—
 - (1) Agrees the Premier, Hon. Jeremy Rockliff MP's budget mismanagement is doing significant long-term damage to Tasmania.
 - (2) Does not support the Premier's plan to privatise public assets.
 - (3) Has no faith in the Premier's ability to deliver major projects following the Spirit of Tasmania fiasco.
 - (4) Further has no confidence in the Premier, the Hon. Jeremy Rockliff MP. (Mr Winter)

A Debate arose thereupon.

Amendment proposed (Dr Woodruff)'.

In paragraph (1) following the word 'Tasmania.', insert the words ', compounded by his plan to fund a new stadium in Hobart.'

A Debate arose thereupon.

And the Question being put – That the Amendment be agreed to.
