

ORDERS IN COUNCIL UNDER SUPERANNUATION ACT.

ORDERS made by the Governor in Council under "The Superannuation Act" since the last Meeting of Parliament.

MONDAY, AUGUST 10, 1874.

MINUTE No. 247.

THE following Pensions or Retiring Allowances are granted under "The Superannuation Act:"-

Queen's Asylum, New Town.

To William Hill, Overseer, £18 14s. 4d. per annum; and to John Say, Beadle, £16 13s. 8d. per annum: both on account of bodily infirmity. To take effect on and from the 1st instant.

To Miss Catherine Horan, a Pension of £36 8s. 7d. per annum, in consequence of the abolition of her office of Schoolmistress. To take effect on and from the 1st July last.

General Hospital, Hobart Town.

To Mr. John Seals, a Retiring Allowance under the 5th Section, of £64 2s. 6d. per annum, in consequence of the re-organisation of the Staff. To take effect on and from 1st June last.

To Mr. John Hines, Gate-keeper, in consequence of bodily infirmity, a Retiring Allowance of £18 4s. To take effect on and from the 1st July last.
