**1 COUNCIL MEETS.**— The Council met at 11.00 o'clock in the forenoon and the President read Prayers.

## 2 LEAVE TO TABLE ADDITIONAL INFORMATION: CONSOLIDATED FUND

**APPROPRIATION BILL (NO.1).**— *Ordered*, That Mrs *Hiscutt* have leave to Table 'Additional Information as Requested by the Legislative Council in relation to the Department of Justice Output 1.10 Workers Rehabilitation and Compensation Tribunal and Output 4.1 Worksafe Tasmania'.

**3 BILLS.**—The following Bills were read the Third time and passed

**4 BILLS.**— A Message to the House of Assembly:—

#### MADAM SPEAKER,

The Legislative Council has this day agreed, without Request and without Amendment, to the Bills intituled ---

'A Bill for an Act for the appropriation of \$4 757 600 000 out of the Consolidated Fund for the services of the Government for the financial year ending on 30 June 2018' (Bill No. 16); and

'A Bill for an Act for the appropriation of \$31 708 000 out of the Consolidated Fund for the services of the Parliament and Statutory Offices for the financial year ending on 30 June 2018' (Bill No. 17)

And now returns the same to the House of Assembly.

**5 BILL NO. 19.**— The Order of the Day was read for the Second reading of the Housing Land Supply Bill 2018.

**6 SITTING SUSPENDED.**—*Resolved*, That the Sitting of the Council be suspended until the ringing of the Division bells. (Mrs *Hiscutt*)

The Sitting was suspended at 12.02 o'clock p.m. and resumed at 12.41 o'clock p.m.

**7 BILL NO. 19.**— The Council, according to Order, resumed the Debate on the Question, That the Housing Land Supply Bill 2018 be now read the Second time.

8 SITTING SUSPENDED.— It being 1.00 o'clock p.m. the Sitting of the Council was suspended.

The Council resumed the Sitting at 2.30 o'clock p.m.

**9 QUESTION TIME.**— The President called for Questions without Notice. There were two Questions asked.

**10 BILL NO. 19.**— The Council resumed the Debate on the Question, That the Housing Land Supply Bill 2018 be now read the Second time.

*Ordered*, That Mrs *Hiscutt*, have leave to Table two documents titled 'Approval process for amendment of planning schemes Part 3 Land Use Planning and Approvals Act 1993' and 'Frequently Asked Questions: Housing Land Supply Bill 2018'.

And the Question being put,

It was resolved in the Affirmative.

And the Bill was, accordingly, read the Second time and committed to a Committee of the Whole Council.

And the President having left the Chair, the Council resolved itself into the said Committee.

Clauses 1 to 28 agreed to.

Title agreed to.

Bill to be reported without Amendment.

The Council being resumed, Ms *Forrest* reported that the Committee had gone through the Bill, and directed her to report the same to the Council without Amendment.

Ordered, That Mrs Hiscutt have leave to move a Motion without Notice.

A Motion was made (Mrs *Hiscutt*) and the Question was proposed, That Standing Order No. 279 be suspended in respect of this Bill, in order that the Bill may be now read the Third time.

A Debate arose thereupon,

And the Question being put,

It was resolved in the Affirmative.

Ordered, That the Bill be now read the Third time (Mrs Hiscutt)

The Bill was read the Third time and passed.

**BILL NO 19.**— A Message to the House of Assembly:—

MADAM SPEAKER,

The Legislative Council has this day agreed, without Amendment, to the Bill intituled ----

'A Bill for an Act to assist the acute demand for housing to be met, by enabling the rapid, appropriate rezoning of certain government land, the alteration of planning provisions that apply to such land, the transfer to the Director of Housing of Crown land that is declared to be housing supply land under this Act, and for related purposes'.
