APPROPRIATION (SUPPLEMENTARY APPROPRIATION FOR 2024-25) BILL 2025

(Brought in by the Treasurer, the Honourable Guy Barnett)

A BILL FOR

An Act for the appropriation of \$467 512 000 out of the Public Account for the services of the Government for the financial year ending on 30 June 2025

Be it enacted by Her Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

1. Short title

This Act may be cited as the *Appropriation* (Supplementary Appropriation for 2024-25) Act 2025.

2. Commencement

This Act is taken to have commenced on 1 July 2024.

3. Interpretation

For the purposes of this Act –

Capital Services means –

(a) public works or property required for public purposes; or

(b) a loan authorised by law;

Operating Services means the ordinary annual services of the Government.

4. Issue, application and appropriation of \$467 512 000

- (1) In respect of the financial year ending on 30 June 2025, the Treasurer may
 - (a) issue the sum of \$467 512 000 out of the Public Account; and
 - (b) apply that sum for the services of the Government.
- (2) The sum specified in subsection (1)(a) is appropriated.

5. Purposes of appropriation

The sum specified in section 4(1)(a) is to be applied for the purposes referred to in Schedule 1 and detailed in either of the following:

- (a) the agency information in support of the estimates for the financial year ending on 30 June 2025;
- (b) the information tabled by the Minister in support of Schedule 1.
