REPORT of the RETURNING OFFICER appointed by the Governor in Council to take the Poll of the Landholders of the RAILWAY DISTRICT, under the Provisions of "The Launceston and Western Railway Act," 29 Vict. No. 24.

SIR,

I BEG to acquaint you that, in accordance with the provisions of "The Launceston and Western Railway Act," 29 Victoria, No. 24, Section 112, the Governor in Council has been pleased to appoint you to be Returning Officer for the purposes of the said Act; with remuneration at the rate of £2 2s. a day, and travelling and personal expenses on the usual scale, while on duty in the Railway District.

His Excellency has also approved of your being provided with clerical assistance if required.

SIR,

REFERRING to my letter of the 16th instant, acquainting you that the Governor in Council had been pleased to appoint you Returning Officer under "The Launceston and Deloraine Railway Act," I have now to direct your attention to the following general instructions as to your performance of the duties devolving upon you by virtue of that appointment.

On all points where the provisions of the Act of Parliament, 29 Vict. No. 24, fail to prescribe specifically the course to be pursued by the Returning Officer, you will be good enough to conform, as closely as possible, to the tenor of these instructions.

1st.—*Preparation of the Polling List. (Sect. 119.)*

In preparing the Polling List specified in Section 119, you will follow, as nearly as the case will allow, the arrangements prescribed by "The Electoral Act," 21 Vict. No. 32.

Consult the Road Trustees and Police Rate Collectors in the several Districts; and when you have compiled the Polling List, assisted and corrected by such information as those authorities can afford you, cause the List to be published in the several Districts, and, after due notice, in the *Gazette* and in two newspapers in Launceston. Attend at each Polling-place named in the Schedule to the Act of Parliament, and revise the List,—sitting in open Court to hear claims and objections, &c.

2nd.—*Printing the Polling List. (Sect. 119.)*

The Government not thinking it desirable that the Polling List should be printed by the Government Printer, you are authorised to cause such printing as the Act requires to be executed in private establishments.

Looking at the state of public feeling in the Northern Division of the Colony, it is desirable that the work should not be assigned to any single office. The Government wish that the printing should be distributed as equally as practicable between the printing offices of the *Cornwall Chronicle* and the *Launceston Examiner*, and you will make your arrangements accordingly.

3rd.—*Appointment of Deputies.* (Sect. 114.)

The Act of Parliament leaves the selection of these Officers to the Returning Officer. The Government have no wish to fetter your discretion in this matter, or to dictate whom you shall name for this duty.

But the Government conceive that you would do well to apply, in the first instance, to the Wardens of Longford, Deloraine, and Westbury, whose official position seems to designate them for this office almost as a matter of course.

You are required by the Act to appoint your Deputies in writing; and you will further require them, before entering upon their duties, to subscribe a Declaration, upon honor, similar to that made by Deputy Returning Officers under "The Electoral Act."

The Government look to you to exercise the utmost caution in making these appointments, so that no exception may be taken to any gentleman named by you on the ground of partizanship on either side of the Railway Assessment question.

You are authorised to offer your Deputies a remuneration of £3 3s. a day while actually engaged in taking the Poll, and such travelling allowance as may be necessary, in addition, to cover the expense of delivering to you personally in Launceston the signed Poll List, Ballot Papers, and Abstract of the Poll.

4th.—*Appointment of Scrutineers.* (Sect. 116.)

You will appoint such Scrutineers as you may think necessary, within the limit named in the Act, in writing, and cause them to subscribe a Declaration, upon honor, to the same effect as that taken by Scrutineers under "The Electoral Act."

The Scrutineers to be named by the Launceston and Deloraine Railway Company may be taken to be appointed to watch the Registration in the interest of the Railway Assessment. You will have no difficulty in appointing as your Scrutineers persons named to you by gentlemen also taking a leading part on the opposite side of the Assessment question.

You will require the Company's Scrutineers to subscribe a Declaration, upon honor, similar to that taken by Scrutineers of your own appointment.

5th.—*Poll Clerks.* (Sect. 115.)

You are authorised to offer a remuneration of £2 2s. a day to Poll Clerks.

You will probably require two such Assistants at the principal Polling-place. But on this point you must be guided by the number of Landholders assigned to each Polling-place.

6th.—*Taking the Poll.* (Sect. 119.)

When "The Launceston and Deloraine Railway Act" is silent, you must be guided in taking the Poll, and in the general conduct of the Election, by the precedents afforded by "The Electoral Act;" and you will give precise instructions to your Deputies to the same effect.

7th.—*Hiring Rooms, &c.* (Sect. 115.)

For the purpose of revising the Polling List and taking the Poll, you are authorised to use, wherever it may be practicable, Public Buildings the property of the Government. In Launceston the Court House will be placed at your disposal. In the Rural Municipalities the Council Chambers will, in all probability, be available for these purposes. At Perth, Evandale, and Carrick you can use the Police Offices, or hire rooms if those buildings are found unsuitable.

You will obtain from the Government Printer such copies of the Valuation Rolls as you may require in conformity with the Act of Parliament.

You are authorised to purchase such stationery and writing materials and other articles as may be necessary for taking the Poll, and to send in accounts, with proper vouchers, for payment at the Treasury.

You will be especially careful to incur no unnecessary expense of any kind, bearing in mind that the cost of the Registration must be defrayed eventually by the Launceston and Deloraine Railway Company.

In furnishing you with the foregoing instructions, the Government deem it unnecessary to give you any further specific directions for your guidance in the discharge of your duties, beyond expressing a confident expectation that you will so conduct the Registration of Landholders as to afford no opportunity for subsequent exception or complaint from any quarter; and that your demeanor towards all parties with whom your official duties may bring you into contact will be marked by uniform courtesy and impartiality, without favour or affection, and without any distinction of persons or politics.

The Government have entrusted to you a delicate and responsible function, and rely with confidence on your capacity and integrity to discharge it efficiently and faithfully.

R E P O R T.

To His Excellency the Governor in Council.

SIR,

HEREWITH I have the honor to transmit to Your Excellency an Abstract of the total result of the Poll of the Landholders of the Launceston and Western Railway District, as taken at the principal Polling-place and the several other Polling-places, on the 18th December instant, under the provisions of the Launceston and Western Railway Act, 29 Victoriae, No. 24; together with the several copies of the Polling List upon which the signatures and registration of the Landholders have been written, signed by myself and by the several Deputy Returning Officers respectively.

The Abstract shows that 1073 Landholders came to the Poll and registered 2822 Votes. There were 9 informal or invalid Ballot-papers, representing 18 Votes. 163 Landholders registered 545 Votes “No;” and 901 Landholders registered 2259 Votes “Yes.” The total number of Landholders on the Polling List was 1403. It results from this Poll that the Landholders have, by a majority of Two out of Three Votes, (and 391 Votes and a fraction to spare) expressed their willingness to be chargeable with a rate in event of deficiency of interest on the Bonds issuable, with the guarantee of Your Excellency in Council, by “The Launceston and Western Railway Company, Limited.”

In forwarding to Your Excellency this formal result of my proceedings as Returning Officer for the Launceston and Western Railway District, I am anxious to express my acknowledgments of the assistance and co-operation I have received from the several gentlemen who undertook the duties of Deputy Returning Officers, by my appointment, and from the Chairmen of the various Road Trusts comprised within the Railway District.

I am also indebted for considerable assistance, in the completion and revision of the Polling List, to the Mayor of Launceston and other gentlemen representing the Launceston and Western Railway Company, Limited; and to Messrs. A. Barrett, J.P.; James Scott, J.P., James R. Scott, J.P., John Mitchell, and J. F. Houghton, representing the Landholders who are opposed to the construction of the Railway on the re-guarantee principle.

In accordance with my instructions from the Honorable the Colonial Secretary, I held open Courts of Revision in Launceston, Evandale, Longford, Carrick, Westbury, and Deloraine.

The result was eminently satisfactory. Public confidence was established in the intentions of the Government to carry out the provisions of the Act of Parliament in a spirit of impartiality and

liberality ; every qualified Landholder in the Railway District was placed upon the Polling List ; and I am not aware of a single instance of a tendered vote being rejected at the Poll, on the ground of the omission of the claimant's name from the List of persons entitled to exercise their franchise under the Railway Act.

The Poll was taken on the 18th December instant, pursuant to a notice under my hand, published, as required by the Act, in the *Gazette* and in newspapers published in Hobart Town and Launceston.

At the principal Polling-place, where I presided in person, the Municipal authorities of the Town of Launceston placed at my disposal the materials and apparatus ordinarily used at civic elections ; and the Mayor was good enough to allow the officers and servants of the Corporation to assist me in several minor preliminary arrangements, which could not have been so conveniently entrusted to unofficial persons.

George Browne, Esquire, the Under-Sheriff, supported me by his presence in the Ballot-room throughout the whole proceedings ; and Mr. District Constable Propsting, of the Territorial Police Force, also attended me during the Poll, at my request, to maintain my authority if occasion arose.

Ample arrangements, however, were made by the Superintendent of the Launceston Municipal Police for the orderly conduct of the Registration, which happily passed off without any necessity for the intervention of the authorities.

In the Rural Municipalities, where the Wardens acted as my Deputies, the Municipal Council Chambers and the services of the Police were courteously placed at my disposal by the Municipal authorities.

At Evandale the Poll was taken before John Ralston, Esq., J.P., now Warden of that Municipality, in the Court of Petty Sessions ; and at Carrick and Perth the Polling took place, in rooms hired in the principal Hotels, before Charles Arthur, Esq., J.P., and Louis Wood, Esq., respectively.

No necessity arose at any Polling-place for resorting to the power of adjournment conferred by Section 122 of the Launceston and Western Railway Act ; and the Ballot terminated throughout the Railway District at 4 p.m. on Monday, the 18th instant.

I declared the rough state of the Poll, as taken at Launceston, at 6 p.m. the same day ; and at noon on Tuesday, the 19th instant, I declared the official result of the Registration throughout the whole Railway District, publicly in the Supreme Court House, Launceston ; when a vote of thanks was unanimously passed to myself as Returning Officer ; and the proceedings terminated, on my proposal, with three cheers for Her Majesty the Queen.

I have attached to this Report an authentic newspaper account of the proceedings on this occasion, which appeared in the *Cornwall Chronicle* of the following day.

I have also appended to this Report all the original documents used by myself and my Deputies in taking the Poll, including my appointments in writing, under the Launceston and Western Railway Act, of Deputy Returning Officers, Scrutineers, and Poll Clerks ; together with the original Declarations made by those officers in accordance with my instructions ; and the appointments in writing of Scrutineers by the Launceston and Western Railway Company, Limited, and the Declarations subscribed, at my desire, by those gentlemen.

I have also thought it advisable to place on record the correspondence which has taken place in connection with my duties as Returning Officer, between myself and the several departments of the Government ; the gentlemen who acted as my Deputies and Scrutineers ; the Mayor of Launceston, and other persons interested in the preparation of the Polling List and the result of the Registration.

I forward herewith copies of this correspondence.

I cannot close my Report without bringing under Your Excellency's notice the courtesy and assistance I have met with from all the officers of the Government with whom my public duty has brought me into contact. I am specially indebted, in this respect, to the Deputy-Commissioner of Crown Lands, and to the Under-Sheriff and Clerk of the Peace, in Launceston ; to the Government Printer ; to the officers of the Survey Department ; to the Director of Public Works and Mr. Gray ; and to the Post Office and Telegraph officials on both sides of the Island.

I should have made this Report earlier, but was delayed by the inadvertent omission of some of my Deputies to attach their signatures to the signed Polling Lists. The last of these documents, duly signed, only reached me this morning.

I forward herewith the Ballot Papers used at the late Registration of Landholders, together with the Abstracts of the Poll taken at each Polling-place, made out and signed, under instructions from myself, by my Deputies.

I trust that I shall be thought to have discharged my commission to the satisfaction of Your Excellency. I am honestly conscious of a single desire, throughout the whole of my official proceedings, to perform my duty with credit to Your Excellency's Government, and with a strict impartiality between the Landholders of the Railway District and the Promoters of the Launceston and Western Railway.

DECLARATION.

I, ROBERT THOMAS COGHLAN-YATES, the Returning Officer appointed by the Governor in Council to take the Poll of the Landholders under the provisions of the *Launceston and Western Railway Act*, [or one of the Deputy Returning Officers; or, a Scrutineer appointed by the Returning Officer; or, a Scrutineer appointed by the *Launceston and Western Railway Company, Limited*; or, a Poll Clerk appointed by the Returning Officer at the ensuing Poll], do hereby declare upon honor that I will faithfully assist in taking the said Poll, and that I will not in any manner interfere with any Landholder when filling up his Ballot-paper, or attempt to ascertain how any Landholder votes; and in case I should ascertain how any Landholder votes, then that I will not disclose to any person the fact so coming to my knowledge, nor by any word or action, directly or indirectly, aid in discovering the same, except in answer to any question which I may be legally bound to answer, or in compliance with the provisions of *The Launceston and Western Railway Act*.

INSTRUCTIONS to Deputy Returning Officers, Launceston and Western Railway District.

(CIRCULAR.)

Public Buildings, Launceston, 14th December, 1865.

SIR,

By this day's mail I have forwarded to you the Papers named in the annexed Schedule, for your guidance and use in taking the Poll at ———, on the 18th instant.

2. In conducting the Registration of Landholders you will be good enough to be guided by the provisions of the Electoral Act on cognate points, as closely as possible, except where specially otherwise directed or empowered by "The Launceston and Western Railway Act."

3. I would desire to call your special attention to the following points:—

4. No Landholder, not a Scrutineer, can be allowed, on any pretence whatever, to re-enter the Ballot-room after he has recorded his Vote; and no Non-electors, save Scrutineers, can be permitted to be present in the Ballot-room during the Poll.

5. No Landholder can be permitted, on any pretence whatever, to vote at any other Polling-place than that to which he is assigned to poll in the certified Lists supplied to you by me.

6. The Scrutineers, appointed by myself and the Company respectively, have been supplied with a form of Declaration to be subscribed by each Scrutineer, and handed to the Deputy Returning Officer for transmission to me at the close of the Poll.

7. You will allow no Scrutineer to be present in that capacity in the Ballot-room who shall decline to subscribe the Declaration, or fail to satisfy you that he has already subscribed it before me.

8. The objections which may be taken to any person tendering his vote by Scrutineers, under the 117th Section of "The Launceston and Western Railway Act," must be decided upon by you in each case by reference to the Valuation Rolls for the Railway District "for the time being," of which I have supplied you with certified copies.

9. But no enquiry can be permitted as to whether or not any Landholder is entitled to the number of Votes assigned to him on the Polling List.

10. If you are satisfied that the person tendering his Vote is "a Landholder within the meaning of *The Launceston and Western Railway Act*," that is, assessed as an owner at £10 annual value on any Valuation Rolls supplied to you by me, you will allow him to vote in terms of his qualification, as set forth in the certified Polling List forwarded to you with the Ballot-papers.

11. No objection, by whomsoever raised, can be entertained after the Ballot-paper is once delivered into the hands of the Landholder tendering his vote; and under no circumstances will you deliver a second Ballot paper to any Landholder after he has retired into the inner room with the Ballot-paper handed to him by you.

12. In the absence of any provision or authority in the Act of Parliament for asking questions, requiring a Declaration, or exacting an Oath from persons tendering their Votes, you must be guided by your own discretion and personal knowledge, assisted by such information as you may be able to obtain from the Poll Clerks and Scrutineers, in deciding any case of disputed identity or alleged personation.

13. You will cause the Placards sent to you to be placed, one or more in each room in your Polling-place, and elsewhere outside the Polling-place in conspicuous positions.

14. You will cause the Poll Clerks to take the Registration of Landholders on the certified Lists marked "A;" and you will mark off, as having voted, the names of Landholders tendering their Votes before delivering to them the Ballot-paper, as prescribed by "The Electoral Act," on the certified Polling List marked "B."

15. At the close of the Poll you will make out an Abstract in triplicate of the Ballot-papers found in the Ballot-box, using the Poll-books supplied to you.

16. You will hand one of these Abstracts to my Scrutineers, and a second to the Company's Scrutineers; the third you will deliver to me personally or by the hands of your Poll Clerk, together with the Ballot-papers, and the Polling Lists used during the Registration, and such Declarations as may have been handed to you by the Scrutineers.

17. In case of an adjournment of the Poll from any cause, as provided for by "The Launceston and Western Railway Act," you will certify the same to me immediately, and seal up the Ballot-box, unopened, in the presence of the Scrutineers, whom you will invite to affix their seals in addition to your own.

18. You are at liberty to declare the rough state of the Poll at your Polling-place if you think fit, at the close of the registration.

19. You will have the goodness to mark with your initials the several Papers now supplied to you, and return the same to me with the Abstract and Ballot-papers.

I AM naturally anxious to make the Polling List as perfect as possible, and shall be glad of assistance from any quarter.

It would scarcely be practicable to submit the draft Polling List to any party, as a portion of it is already in the printer's hands.

But there are points on which your local experience would, no doubt, materially assist me; and, under the circumstance of your present suggestion, I can have no hesitation in naming them to you.

1st. As to identity, or duplicate Names.

2nd. As to the Names of Executors and Trustees.

I am given to understand that the Promoters of the Launceston and Western Railway have already compiled a complete List of the Freeholders within the Railway District. It is, therefore, unnecessary for me to send you a list of the duplicate names; but it would be a material assistance to me to learn from you what names in this class represent the same individual, and where two or more individuals are represented by the same name.

As regards Trustees and Executors: here again you could afford valuable assistance, by supplying me in detail with the names of the persons, in each case, acting in those capacities. I may find it necessary to deal with some of them as "Joint Tenants;" and it is on that ground specially necessary to learn their names, which are not shown by the Valuation Rolls.

There are two other points on which, I imagine, it is peculiarly in your power to assist me in compiling the Polling List as perfectly as possible.

(a.) There are no Trustees for the Road District of Breadalbane.

(b.) The Road District of Evandale is only in part included within the Railway District.

I should be thankful to obtain from you a List of the Freeholders of £10 and upwards resident within the Road Trust District of Breadalbane, and of Evandale as included in the Railway District.

I enclose you Valuation Rolls for the Districts of Launceston and Morven.

I should feel obliged by receiving them again from you with the names of the Breadalbane and Evandale Railway Electors marked off on them with the letters B and E respectively.

DECLARATION OF POLL.

ROBERT THOMAS COGHLAN-YATES, *Esq.*, the Returning Officer, made the Official Declaration of the Poll at noon yesterday, at the Court House in Patterson-street. Several hundred persons were present.

The Returning Officer, who addressed the assemblage from the Bench of the Supreme Court, said:—

Gentlemen, Landholders of the Launceston and Western Railway District, I am now in a position to announce to you officially the result of the Registration which took place yesterday, pursuant to the provisions of the *Launceston and Western Railway Act*. I am not required by law to make this declaration; but I have determined upon this course in order to satisfy your natural anxiety to be made acquainted with an authentic account of the result of yesterday's Poll. (Hear hear.) The number of votes recorded in favour of the construction of the Railway, upon the principles sanctioned by the Act of last Session, is 2259. The number of votes against the construction of the Railway on these principles is 545. There were 9 invalid papers, representing 18 votes. The number of Landholders who voted for the Railway is 901: and of those who voted against its construction on the re-guarantee principle, 163. The total number of Landholders who came to the Poll was 1073. Such is the abstract of the Poll,

which it is my duty to transmit to the Governor in Council. You will observe that this result gives a majority in favour of the construction of the Railway considerably larger than the two-thirds required by law. It affords me much gratification to be able to bear testimony, so far as my observation has gone during the course of yesterday's proceedings, to the admirably orderly and intelligent manner in which the Landholders exercised their franchises under the Railway Act. It is a remarkable and gratifying fact that, throughout the whole Railway District, out of so large a number of persons voting as 1073, only 9 invalid papers were found in the ballot boxes at the close of the Poll. I may be allowed to accept this result as a proof that the Landowners were thoroughly alive to the nature of the proceedings, and that every provision had been made for giving effect to the free expression of their real opinions. In my position as Returning Officer I have always maintained a position of profound neutrality on the question of the Railway; but I may be permitted now to congratulate you on a result which will I trust put a period, at once and for ever, to those bitter and acrimonious feelings (hear hear) which have too long, unhappily, divided the Northern community into hostile sections: harmony is now, let us hope, once more restored. (Cheers.) Allow me at the same time to assure you, in all sincerity, of my earnest and anxious hope that, now that the Railway is at last placed within your reach, it may prove productive to this part of the Colony of all those material benefits which have always been predicted as the result of its achievement, by those who have for so many years been its enthusiastic advocates and supporters. I must also take this occasion to express my satisfaction at the result of the adoption of the plan of open revision of the Polling List, in the several divisions of the Railway District. I feel assured that it has been productive of the most satisfactory result. I do not believe that there is a single Landholder in the Railway District who could now stand forward and say that he had been deprived of his franchise under the Railway Act by any inaccuracy in the Polling List, or any fault of the Returning Officer. (Cheers.) I must also express my acknowledgments of the assistance I have received in the revision of the Polling List from His Worship the Mayor of this town and other gentlemen on the one side, and from Messrs. James Scott and J. Mitchell on the other,—who, in the exercise of their legitimate right as Landholders, took the opposite side of the re-guarantee question. I am also much indebted for the satisfactory conduct of this important election to the able assistance I have received from my Deputies throughout the Railway District, and from my own and the Company's Scrutineers. Gentlemen, it only remains for me to state that I shall report the result of the Poll to the Governor in Council, in accordance with the statement I have now officially delivered to you. (Loud cheers.)

Mr. Alderman Sheridan said he thought the whole management of the proceeding from first to last must have satisfied every one that the Returning Officer had performed his duty efficiently, satisfactorily, and impartially; and he should therefore propose a vote of thanks to that gentleman for his conduct in the election.

Mr. John Mitchell seconded the motion, which was carried unanimously by acclamation.

The Returning Officer, in acknowledging the vote of thanks, said he was deeply gratified at this indication of their approval and satisfaction. He accepted that vote as the rational and intelligent judgment of the Landholders of the Railway District; and as a popular ratification of the selection of himself, by the Governor in Council, for an office of peculiar delicacy and no inconsiderable responsibility—his execution of which, he believed they now admitted, had fully justified the confidence reposed in his integrity and capacity by Her Majesty's Government. (Cheers.) He would now ask them to conclude the proceedings, as became Englishmen, with three cheers for Her Majesty the Queen.

Three cheers were then heartily given for the Queen, and the large assembly dispersed.
