- 1 The House met at Ten o'clock a.m.
- 2 ACKNOWLEDGEMENT OF TRADITIONAL PEOPLE. - The Speaker made a statement acknowledging the traditional people of the land.
- 3 PRAYERS AND REFLECTION. - The Speaker read Prayers.
- 4 QUESTIONS SEEKING INFORMATION. - In accordance with Standing Order No. 43, Questions without notice commenced.
- 5 PAPERS. - The Minister for the Prevention of Family Violence laid upon the Table of the House the following Paper:-
Tasmanian Government: Document entitled "Hearing Lived Experience - Family and Sexual Violence Survey 2022".
- 6 QUESTIONS SEEKING INFORMATION. - Questions without notice continued and concluded.
- 7 PETITION. - Mr *Tucker* presented a Petition from approximately 273 citizens of Tasmania, requesting that the House provide support and assist with the approval of the Epuron's application for 50 wind turbines at St Patricks Plains. (HA2/2022).
