## TUESDAY, 23 MARCH 2021

**1 COUNCIL MEETS.**— The Council met at 11.00 o'clock in the forenoon.

**2 ACKNOWLEDGEMENT OF TRADITIONAL PEOPLE.**— The President said: "We meet today on Tasmanian Aboriginal land. We acknowledge and pay respect to the Tasmanian Aboriginal people and elders, past and present. We recognise them as the traditional and original owners and the continuing custodians of this land."

**3 PRAYERS.**— The President read Prayers.

**4 E-PETITION.**— Dr *Seidel* brought up an E-Petition from 248 electors of Huon calling on the Government to support the construction of a pedestrian pathway between Oyster Court and Oxleys Road on the Channel Highway, Kettering.

*Ordered*, That the Petition be received. (Dr *Seidel*)

**5 E-PETITION.**— Ms *Forrest* brought up an E-Petition from 718 citizens of Tasmania calling on the Government to ensure support for youth with mental health challenges including eating disorders.

Ordered, That the Petition be received. (Ms Forrest)

**6 PETITION: GOVERNMENT RESPONSE.** Mrs *Hiscutt* laid upon the Table of the Council the Government Response to the following Petition: Preservation of Garden Island Creek and Garden Island Sands from erosion and provision of safe beach access.

- (6) Ms *Rattray* Clean Up Day.

At the conclusion of Special Interest Matters the Council proceeded to Orders of the Day.

11 STATEMENT BY THE PRESIDENT -EDITH COWAN .- The President said --

"Honourable Members I wanted to make a brief statement to the Council before we proceed to Orders of the Day.

I wanted to draw to the attention of Honourable Members that this year marks the centenary of the election of the first woman Member of an Australian Parliament.

It was Edith Dircksey Cowan who was elected to the Parliament of Western Australia on 12 March 1921. Edith Cowan had always argued for women to be part of public life and stood for election just one year after women were granted the right to sit in the Parliament of Western Australia.

Although a Member of the Government, Edith Cowan advocated strongly for women and children, particularly in the area of health. Although a Member of the Government, she did not always vote on party lines, but she always voted in a way that would benefit women and children. She successfully presented two private Members Bills, to give equal inheritance rights to women when children died intestate and to allow women to enter the legal and other professions.

Although Edith Cowen served only one term, her legacy is significant and should be acknowledged. Women continue to serve in every House of Parliament in Australia and at the highest levels of Government. This year certainly marks a special centenary."

**12 SITTING SUSPENDED.**—*Resolved*, That the Sitting of the Council be suspended until the ringing of the Division bells. (Mrs *Hiscutt*)

The Sitting was suspended at 11.52 o'clock a.m. and resumed at 12.55 o'clock p.m.

The Question was again proposed, and the Council resumed the Debate.

**14 SITTING SUSPENDED.**— It being 1.00 o'clock p.m. the Sitting of the Council was suspended.

The Council resumed the Sitting at 2.30 o'clock p.m.

**15 QUESTION TIME.**— The President called for Questions without Notice. There were nine Questions asked.

**16 BILL NO. 45 OF 2018.**— The Council resumed the Debate on the Question, That the Public Health Amendment (Prevention of the Sale of Smoking Products to Under-age Persons) Bill 2018 be now read the Second time.

*Ordered*, That Mr *Dean*, have leave to Table the Menzies Institute for Medical Research, University of Tasmania research into T21 in Tasmania and to Table a Report to the Minderoo Foundation and Smoke Free titled Tasmania T21: Raising the minimum age of tobacco sales in Tasmania to 21 years Economic Analysis dated June 2020.

Ordered, That the Debate be adjourned. (Dr Seidel)
