We do have a 'wait list' however, we like to stress that the 'wait' is for a residential bed. If people seek treatment, we can usually connect them with a worker very quickly and begin the process of working through their treatment goals and determining the best treatment pathway, which may or may not include a residential bed.

With the new beds though, we don't have a particularly long wait for a bed, however there is a wait for detox beds.
