- 1 The House met at Ten o'clock a.m.
- 2 ACKNOWLEDGEMENT OF TRADITIONAL PEOPLE. The Speaker made a statement acknowledging the traditional people of the land.
- 3 PRAYERS AND REFLECTION. The Speaker read Prayers.
- REFLECTION ON THE SPEAKER. The Honourable Member for Clark, Mr *Bayley*, made a statement to the House noting that the Speaker had written to him to unreservedly withdraw and apologise for comments made about the Speaker on Twitter on 18 August. Mr *Bayley* further acknowledged he was unaware of the tenet of parliamentary practice whereby the Speaker's actions may only be criticised by a substantive motion being moved in the House and would bear this in mind in the future. Mr *Bayley* unreservedly withdrew the comments and apologised
- **5** QUESTIONS SEEKING INFORMATION. In accordance with Standing Order No. 43, Questions without notice were asked.
- 6 PRIVILEGE: CONTEMPT FOR FAILURE TO COMPLY WITH AN ORDER OF THE HOUSE. Ms White said:-

"Mr Speaker, I raise a question of privilege in accordance with Standing Order 81. I move - That the Minister for Energy and Renewables, the Honourable Guy Barnett, having been ordered by the House to -

- (1) Outline to the House, before 6pm on 16 August 2023, the latest cost estimate for:
 - (a) Marinus Link;
 - (b) North West Transmission Developments; and
 - (c) Battery of the Nation projects,

and having failed to do so, this House refers the Minister to the Privileges and Conduct Committee."
