Legislative Council Estimates Committee 'B' examined the Estimates of the Department of Premier and Cabinet, Hon Cassy O'Connor MP on Wednesday, 30 May 2012.

The Committee examined the Estimates for the Aboriginal Affairs portfolio and although there is no Output Group under the responsibility of the Minister, noted that funding was derived through Output Group 6 – Community Development. This was resolved for further debate under Division 9, Output Group 6 – Community Development.

The Committee recommends that appropriate steps be taken by the Minister for Aboriginal Affairs, in conjunction with the Department of Treasury and Finance, to amend the future Budget Papers to include a separate Output Group or line item for the Aboriginal Affairs portfolio. The Committee further recommends that consideration be given to whether current Aboriginal Heritage funding under of Output Group 9 — Heritage, Department of Primary Industries, Parks, Water and Environment, should more appropriately reside under the responsibility of the Minister for Aboriginal Affairs.
