BOARD OF IMMIGRATION:

REPORT FOR 1878.

Laid upon the Table by the Colonial Secretary, and ordered by the House to be printed, September 9, 1879.

SIR.

THE Board of Immigration have the honor to forward their usual Report for the year ended the 31st December, 1878.

There was an increase of thirty-seven in the number of Immigrants introduced under the Bounty System as compared with the year 1877.

The Immigrants introduced consisted of five married couples, three single males, eleven single females, twelve male and eight female children, in all forty-four souls, the cost to the Board of their introduction being three hundred and sixty-eight pounds.

Nine males and thirteen females came from England, six males and eight females from Ireland, and five males and three females from Scotland.

Land Certificates were issued to thirty-two individuals under the 7th Section of the Act of Parliament, 31 Vict. No. 26, entitling the holders to select eighteen hundred and seventy acres of the waste lands of the Crown. These Certificates represent twenty-eight male and twenty-one female adults, and fifty-eight children,—in all one hundred and seven souls.

Five Land Orders were issued under the 5th Section of the same Act entitling the holders to select three hundred and six acres of the waste lands of the Crown, and representing five male and three female adults and sixteen children,—in all twenty-four souls.

During the year the Board issued four family, nine male, and eight female Bounty Tickets, receiving the sum of one hundred and ninety pounds.

The edition of the Paper entitled "Information for Intending Emigrants," ordered by the Board, has been printed, and 1000 copies forwarded to the Colony.

When a Bounty Ticket is issued a copy of this Paper is also sent to the purchaser with the recommendation that it should be forwarded by book-post to the person for whom the Ticket is intended, thus aiding in the dissemination of information regarding the Colony.

Mr. Richall Richardson, who contemplated travelling through England with an Exhibition of Tasmanian Products and lecturing on the Colony, unfortunately lost his life at Macquarie Harbour, and the 2000 copies of the before-mentioned Paper which the Board directed to be placed at his disposal were handed over to the Board's Agents in England, in addition to the 7000 copies previously allotted to them.

The Board have sanctioned their Agents in England issuing a limited number of Bounty Tickets at the regulated prices, chiefly with the view of their sending out a selection of female domestic servants; and the Agents write that they hope to dispose of these tickets to well-recommended female servants during the course of the present year.

The Board's Agents also state that there is an increasing desire for information respecting the Colony as a field for emigration, and by a cheap but extensive system of advertising they have endeavoured to bring the Colony more prominently before the public in Great Britain.

The balance at the disposal of the Board on the 31st December amounted to £5273 6s. 7d.

Appended are the customary Returns prepared by the Immigration Agent,—five relating to the operations of the Board under the Bounty System, and two to transactions under the Acts of Parliament 31 Vict. No. 26, and 38 Vict. No. 16.

A statement is also appended showing the acreage taken up by the holders of Land Certificates and Land Orders since the date of the last Report.
