

### BRIDGE OVER SOUTH ESK AT AITKEN'S FORD.

My predecessor's report sets forth that the promoters of this work recommended a low level bridge, but that the Government did not consider it desirable to carry out this kind of structure.

A further inspection of the proposed sites has been made by this Department, and a suitable one having been obtained a fresh design for a high level bridge has been prepared, the estimated cost being about  $\pounds 1350$ . This design was submitted to the Promoters; and on the 8th June I received a letter from the Chairman, informing me that at a meeting held on the 23rd May last the following decision was arrived at:—"That the Promoters consider the present plan too expensive for the locality."

# BRIDGE OVER THE HUON RIVER AT VICTORIA.

The District having decided in favour of this work as required by the Local Public Works Amendment Act, 1873, and Promoters having been elected, two designs for a suitable structure were prepared in this office and submitted to the Promoters; No. 1 design being for a Laminated Arch Bridge, No. 2 for a Queen-bolt Truss Bridge. The entire length of bridge will be about 544 feet, width 14ft. 6in.

The Promoters wished tenders to be invited for both designs before they would finally decide on either. This has been done, and the Promoters recommend for acceptance the tender of Jno. Helmer at £3295, being the lowest, for Bridge according to No. 1 Plan. Owing however to certain questions having arisen with reference to the liability of the Promoters should any claims be made for compensation on account of the navigation of the river being interfered with by the Bridge, the final acceptance of the tender has been deferred for the present.

#### BRIDGE OVER THE RIVER MERSEY AT LATROBE.

The District decided in favour of this work under the Act of 1872, and Promoters have been elected. A design for a bridge of one span was obtained by the Promoters and transmitted to this Department, but no specification was received therewith. It was however considered that a more suitable structure could be erected, and certain suggestions were accordingly made to the Promoters. Considerable correspondence has taken place on the subject, but as yet no satisfactory arrangement has been arrived at. The Promoters in the meantime, without consulting this Department, invited tenders for the bridge according to their design, and for other works, including 25 chains of roadway, which were not considered to come within the meaning of "works" to be constructed under the Local Public Works Act; and the only tender received is from Martin Boland at £3220 for the bridge and proposed roadway, &c.; whereas £2000 is the amount mentioned as sufficient for the bridge in the approval of His Excellency, declaring that the same is to be constructed under the provisions of the Local Public Works Act. f. s. d.

#### BRIDGE OVER RIVER DERWENT AT NEW NORFOLK.

The District has decided in favour of this work as required by "The Local Public Works Amendment Act, 1873," and Promoters have been elected.

The Promoters were anxious to obtain from the Government the Iron Suspension Bridge originally designed, and procured from England in 1855, for Perth, (but which has been in store ever since), and if practicable to have it erected.

The position of the present Bridge being altogether unsuitable for this structure, except at a very large outlay, the Promoters considered that an eligible site could be obtained within a reasonable distance of New Norfolk, and requested that an examination of the river might be made for this purpose. The one referred to by the Promoters; viz.—near the Falls—was considered the most eligible, although not altogether favourable—and, as requested by the Promoters, I instructed a survey of the site to be made, and sections furnished, in order that an estimate of the cost of erection of the Iron Bridge might be prepared.

This has been done, and particulars transmitted to the Promoters, with other information in connection with a Wooden Bridge at the present site; and the matter remains undecided.

# BRIDGE OVER THE RIVER MEANDER AT DELORAINE.

The District decided in favour of this work as required by "The Local Public Works Act of 1872."

The initiators of the scheme invited Designs for a Bridge at a cost not exceeding  $\pounds4000$ ; but the Government considering that such a large outlay was quite unnecessary—as a Bridge in every way suited to the requirements of the locality could be erected for a sum not exceeding  $\pounds2000,$ —declined to recommend for His Excellency's approval any larger amount than the last-named sum for this work.

Another Petition has, however, been received in accordance with "The Local Public Works Amendment Act," and the District having decided in favour of the work the Governor in Council has declared that the Bridge shall be constructed under the provisions of "The Local Public Works Act," at a cost of not exceeding £2000, and Promoters have been elected accordingly.
