Notices of Motion

- 195** The Minister for Police, Fire and Emergency Management to move—That the House:—
- (1) Recognises that 27 September 2019 is National Police Remembrance Day.
 - (2) Notes that Remembrance Day is a sobering reminder of the potential dangers that police officers sometimes face while trying to protect our communities.
 - (3) Further notes that a service to honour the fallen members of Tasmania Police will be held at the Tasmania Police Academy on Friday 27 September 2019.
 - (4) Remembers and pays tribute to the memory of all police officers who have lost their lives and their families that have lost a loved one serving the Tasmanian community. They have all undertaken important duties that have contributed to making our communities a safer place to live and have made the ultimate sacrifice in keeping others safe.
 - (5) Further notes that Remembrance Day is also a time to reflect on the hard work and dedication of all Tasmanian Police Officers and the contribution that they make to Tasmania. (26 September 2019)
- 196** Ms O'Connor to move—That the House censures Hon. Elise Archer MP, Hon. Guy Barnett MP, Dr Shane Broad MP, Ms Jenna Butler MP, Hon. Sarah Courtney MP, Ms Anita Dow MP, Hon. Michael Ferguson MP, Hon. Peter Gutwein MP, Ms Eloise Haddad MP, Hon. Susanne Hickey MP, Hon. William Hodgman MP, Ms Jennifer Houston MP, Hon. Roger Jaensch MP, Mr David O'Byrne MP, Ms Jacqueline Petrusma MP, Hon. Jeremy Rockliff MP, Mrs Joan Rylah MP, Hon Mark Shelton MP, Ms Alison Standen MP, Mr John Tucker MP, and Hon. Rebecca White MP on the following grounds:—
- (1) the Members' failure to offer meaningful support to young people in their fight for a safe climate.
 - (2) the Members' failure to stand up to their Federal colleagues' shameful advocacy for the coal, oil and gas industries - as well as their willingness to accept donations from these industries.
 - (3) the Members' shameful support for logging natural forest carbon banks.
 - (4) the Members' complicity in global climate and environmental vandalism that has led to a climate and biodiversity emergency. (26 September 2019)
- 197** Mrs Rylah to move—That the House:—
- (1) Acknowledges that the Hodgman majority Liberal Government has a long-term plan to keep our economy strong, carefully manage the Budget, help create jobs, and invest even more in essential services.
 - (2) Notes that, at the State election in March 2018, Tasmanians saw the progress that had been made in delivering our plan, across our State, in four years under a majority Liberal Government, and they supported it again.

- (3) Recognises that a vital part of the plan was to first and foremost, restore business confidence and strengthen our economy.
- (4) Further notes that Tasmania's businesses are now measured as the most confident in the nation, that Tasmania has the best business conditions in the nation and that Tasmanian small businesses are the powerhouse of our economy.
- (5) Further acknowledges the Shadow Treasurer, Hon. David O'Byrne MP's public admission this week that, after five and a half years in Opposition, Labor still has no vision or plan.
- (6) Endorses the Hodgman majority Liberal Government's plan to continue to grow the economy and help create jobs, by supporting Tasmanian businesses and unlocking investment opportunities in Tasmania. (15 October 2019)

198 The Treasurer to move—That the House approves, in accordance with sub-sections 11(7) and 12 (4) of the Public Account Act 1986, additional Recurrent Services and Works and Services expenditure in 2018-19 for the purpose detailed in the Section 19 Return for the June Quarter 2019. (15 October 2019)

199 Ms *Haddad* to move—That the House:—

- (1) Notes the concern of Westbury residents about the decision of the Hodgman Liberal Government to build a new maximum security prison on their doorstep.
- (2) Laments the secrecy and lack of consultation with the community prior to the announcement.
- (3) Calls on the Hodgman Liberal Government to detail how much it has paid a public relations firm to outsource the consultation process.
- (4) Further calls on the Hodgman Liberal Government to reveal the other nine shortlisted sites to fully inform debate about the best location for the northern prison. (15 October 2019)

200 Ms *Woodruff* to move—That the House:—

- (1) Acknowledges thermal coal combustion is a key driver of increasing greenhouse gas emissions and rising global temperatures.
- (2) Recognises the impact just 1.1 degrees of warming is having on Tasmania, including extreme floods, East Coast drought and marine heatwave, increased dry lightning storms and destructive bushfires, coastal erosion, biosecurity threats and ecosystem stress.
- (3) Accepts the scientific consensus that burning fossil fuels – such as coal – must end in order to limit warming and prevent climate breakdown.
- (4) Agrees it is in Tasmania's best interest to be a climate positive, clean energy island.
- (5) Notes Tasmania's natural, clean energy powered brand would be damaged by any new coal mines, and this brand damage would flow on to the agricultural and tourism sectors of the economy.
- (6) Commits to a prohibition on new thermal coal mines in Tasmania. (15 October 2019)

201 Ms *O'Byrne* to move—That the House:—

- (1) Notes the significant community concern about the proposed closure of the TasTAFE campus in the Launceston CBD.
- (2) Recognises the problems with the current aging infrastructure at the Alanvale campus.
- (3) Further notes the recent delays and cancellations to courses faced by students studying information technology, plumbing and electrotechnology.
- (4) Further notes the serious issue of understaffing at TasTAFE and its effect on teaching staff.
- (5) Further notes the decision by the University of Tasmania to relocate its Newnham campus to the CBD.
- (6) Further notes the difficulties faced by businesses across a range of industries that are desperate to find skilled staff.
- (7) Further notes Tasmania has lost 5,600 full time jobs in the past year and has a youth unemployment rate of 13.7 per cent.
- (8) Calls on the Premier, the Hon. Will Hodgman MP, to rule out the closure of the TasTAFE campus in the Launceston CBD. (15 October 2019)

202 Ms *O'Connor* to move—That the House:—

- (1) Notes the significance of Parliament Lawns for the facilitation of protests and peaceful presentation of political views to Members of Parliament.
- (2) Acknowledges that Tasmanian members of the global climate activist movement, Extinction Rebellion, have had a near-constant presence on Parliament lawns for some months.
- (3) Agrees these Tasmanians have been fostering awareness of the climate emergency, and have engaged in a friendly and welcoming manner with the public on the lawns, spreading an important message in a positive way.
- (4) Commends these Tasmanians for their dedication to a safe climate, and agrees that their advocacy has been beneficial for our state and our democracy. (15 October 2019)

- (2) Further congratulates, subject to final confirmation, the election of Tasmanian Federal Liberal representatives in both the Senate and the House of Representatives.
- (3) Notes the strong relationship between the Hodgman and Morrison Governments, working together to deliver a stronger economy, real investment in infrastructure and better health and education services for all Tasmanians. (Next Speaker: Dr *Woodruff*)

5 Battery of the Nation: Adjourned Debate on the Question proposed on Wednesday, 31 July 2019 by Mrs *Rylah*—That the House:—

- (1) Notes Tasmania has the renewable and dispatchable energy the rest of the nation needs, and the Hodgman Liberal Government is committed to using this advantage to ensure all Tasmanians benefit.
- (2) Records this Governments continuing drive for the development of the Battery of the Nation and the crucial second interconnector, the Marinus project, which have the potential to inject up to \$5 billion into the Tasmanian economy and deliver 2,000 jobs, particularly into regional areas.
- (3) Further notes that the development stage of the first phase of the Battery of the Nation carries the commitment of the Federal Government through the Federal Underwriting New Generation Investment program.
- (4) Further notes that support by both the Hodgman Liberal Government and the Federal Government, gives UPC Renewables and AC energy, more confidence to develop their Robbins Island and Jims Plain wind and solar parks.
- (5) Recognises that Tasmania has a world-class wind resource complemented by our pumped hydro that means there will always be some electricity available for export when the mainland is experiencing low wind or high demand.
- (6) Acknowledges that the Australian Government clearly recognises the importance of Tasmania's energy solutions and our status as the leading energy state.
- (7) Commends the Hodgman Liberal Government for its strong commitment to making use of the natural resources available to the State while at the same time ensuring all Tasmanians will have access to low cost, reliable and clean energy in their homes and businesses. (Mrs *Rylah*)

NOTICES OF MOTION AND ORDERS

To which the following amendment has been proposed by Dr *Woodruff*, by leaving out all words after “That the House:-” and inserting instead:

- “(1) Notes that the Liberals repeatedly talk about the Marinus project and use it as a political wedge, particularly during election periods, despite the fact that they have not put forward a financing proposal or a position on who should finance the multi-billion project.
- (2) Agrees that the project could cost in excess of current total Public Non-Financial Corporations Sector debt, and feasibility studies and prominent economists such as Saul Eslake have raised serious concerns about the viability of the project, which have not been addressed by the State Government.
- (3) Notes that the Liberals passed legislation to set wholesale electricity prices at a rate higher than projected, leading to energy bills decreasing by less than they would otherwise would have.
- (4) Notes with alarm that the Liberal Government continues to allow Entura to engage in profiteering from immoral projects overseas such as the Karuma hydro power project Uganda, which has been linked to killings and other human rights violations.
- (5) Condemns the Liberal Government for their lack of honesty, ethics or plan in their handling of the Energy portfolio.” (Next Speaker: Minister for Energy)

6 Minimum Mandatory Sentences: Adjourned Debate on the Question proposed on Wednesday, 7 August 2019 by Mr *Tucker*—That the House:—

- (1) Welcomes the Federal Labor party’s recent sensible backflip on minimum mandatory sentences for crimes relating to child abuse.
- (2) Acknowledges the Tasmanian Labor Party is now out of step with its Federal Labor colleagues.
- (3) Supports the introduction of minimum mandatory sentences for serious sexual offences against children. (Next Speaker: The Attorney-General)

7 Housing and Homelessness: Adjourned Debate on the Question proposed on Thursday, 8 August 2019 by the Minister for Housing—That the House:—

- (1) Acknowledges the dedicated work that is being done every day in the community and housing sectors to support Tasmanians experiencing homelessness or who are at risk of homelessness.
- (2) Further acknowledges that homelessness is often linked to other challenges such as mental illness, and the Tasmanian Government is focusing on the integration of mental health services to provide more holistic support and greater independence for clients.
- (3) Further acknowledges that Tasmania’s Affordable Housing Strategy is responding to the current challenges in the housing market by boosting supply across a spectrum of needs.
- (4) Further acknowledges that the Affordable Housing Action Plan Stage 2 and the additional investment in funding is another positive step towards continuing this momentum.
- (5) Recognises that all levels of government have a role to play in addressing the supply and demand in our housing market.
- (6) Call on all Members to work together to put the needs of Tasmanians above political point scoring. (Next Speaker: Minister for Housing)
