- **8** MINISTERIAL STATEMENT MINISTERIAL APPOINTMENTS. The Premier said: "Mr Speaker, I wish to advise the House of changes in ministerial responsibilities following the resignations of *Sarah Courtney* from the Cabinet and the Parliament, and Hon. *Jane Howlett* MLC from the Cabinet.

I have again taken on the responsibility for the Climate Change and Tourism portfolios.

The Member for Franklin, Mr *Street*, was sworn into Cabinet last month as the Minister for Sport and Recreation, Community Services and Development, Science and Technology, and Heritage.

The Member for Clark, Ms *Ogilvie*, was sworn in as Minister for Small Business, Disability Services, Women, Racing, and Hospitality and Events.

Minister *Roger Jaensch* has taken on responsibility for the new combined portfolio of Education, Children and Youth, as well as the Skills, Training and Workforce Growth portfolio. He retains State Growth and Aboriginal Affairs.

Minister *Michael Ferguson* will now be responsible for the Local Government and Planning portfolio, while his Science and Technology portfolio has transferred to Mr *Street*. He retains his other ministerial responsibilities.

I have also appointed a new Parliamentary Secretary to the Premier, the Member for Braddon, Mr *Ellis*, who will also be the Government Whip going forward.

The member for Lyons, Mr *Tucker*, will be the Government's nominee for Deputy Speaker and Chair of Committees. I thank him for his work as Parliamentary Secretary and as previous Whip."
