1 COUNCIL MEETS.— The Council met at 11.00 o'clock in the forenoon and the President read Prayers.

2 ACKNOWLEDGEMENT OF TRADITIONAL PEOPLE.— The President said: "We meet today on Tasmanian Aboriginal land. We acknowledge and pay respect to the Tasmanian Aboriginal people and elders, past and present. We recognise them as the traditional and original owners and the continuing custodians of this land."

3 PAPERS.— The Clerk of the Council laid upon the Table the following Papers:—

6 LEAVE OF ABSENCE. *Ordered*, That the Honourable Member for Rumney, (Ms *Lovell*) be granted leave of absence from the service of the Council for this day's sitting. (Mrs *Hiscutt*)

7 STATEMENT BY THE PRESIDENT – NEW LEGISLATIVE COUNCIL STAFF MEMBERS.— The President said —

"Honourable Members, before proceeding to the business of the day it is with pleasure that I formally and very warmly welcome recent additions to the staff of the Legislative Council, Lisa Patterson, Tahnee Byas and Megan Graham.

Lisa commenced in the role of Electorate Officer to the Member for Rosevears on 11 July 2022. Lisa has extensive experience in supporting a Member of Parliament having previously been engaged as an Electorate Officer for the Member for Bass since 2019, serving former Member of Parliament and Minister, Sarah Courtney and recently Lara Alexander MP.

Tahnee commenced duties in the office of the Member for Rumney on 18 July 2022 and has extensive experience and expertise having worked in an executive assistant role for the past 11 years.

Megan commenced in her role as Electorate Officer to the Member for Huon on 15 August 2022. Megan was previously employed with the Huon Valley Council and has extensive professional experience in the Huon Electorate including involvement in a variety of community organisations. Megan also has electorate office experience having worked in the offices of Nic Street MP and Paul Harriss, the former Member for Huon.

Lisa, Tahnee and Megan will be observing proceedings in the Legislative Council today as part of their orientation to the Council. On behalf of all Members I extend to them a very warm welcome."

- (2) Notes the grounding Little Athletics has given to Tasmanian athletes who have gone on to represent Tasmania and Australia on the National and International stage.
- (3) Acknowledges the significant role volunteers play within such organisations.
- (4) Notes the overall positive contribution such organisations make to the fabric of the Tasmanian society.

A Debate arose thereupon.
