A Bill for an Act to regulate the gas industry, to provide for safety and technical standards that ensure that the gas supply industry, gas facilities, gas installations, gas appliances, gas storage systems and gas conditioning systems are constructed, maintained and operated to a high standard of safety and in a manner that protects persons and property, and for related purposes (Bill No. 41)

A Bill for an Act to amend certain legislation consequent on the enactment of the Gas Industry Act 2018 and the Gas Safety Act 2018 (Bill No. 42)
