

Notes on Clauses

Consolidated Fund Appropriation (Supplementary Appropriation for 2013-14) Bill 2014

- Clause 1 This clause provides for the title of the Act to be the *Consolidated Fund Appropriation (Supplementary Appropriation for 2013-14) Act 2014*.
- Clause 2 The Act is taken to have commenced 1 July 2013, the commencement of the current financial year (2013-14).
- Clause 3 This clause provides for the appropriation of \$92 599 000 from the Consolidated Fund.
- Clause 4
- (1) The sum of \$3 102 000 is to be applied to Division 1 of Part 2 of Schedule 1 to the *Consolidated Fund Appropriation Act (No.1) 2013*, Department of Economic Development, Tourism and the Arts, representing a Recurrent appropriation.
 - (2) The sum of \$40 690 000 is to be applied to Division 2 of Part 2 of Schedule 1 to the *Consolidated Fund Appropriation Act (No.1) 2013*, Department of Education, representing a Recurrent appropriation.
 - (3) The sum of \$32 281 000 is to be applied to Division 3 of Part 2 of Schedule 1 to the *Consolidated Fund Appropriation Act (No.1) 2013*, Finance-General, representing a Recurrent appropriation.
 - (4) The sum of \$1 112 000 is to be applied to Division 4 of Part 2 of Schedule 1 to the *Consolidated Fund Appropriation Act (No.1) 2013*, Department of Health and Human Services, representing a Recurrent appropriation.
 - (5) The sum of \$119 000 is to be applied to Division 5 of Part 2 of Schedule 1 to the *Consolidated Fund Appropriation Act (No.1) 2013*, Department of Infrastructure, Energy and Resources, representing a Recurrent appropriation.
 - (6) The sum of \$2 620 000 is to be applied to Division 6 of Part 2 of Schedule 1 to the *Consolidated Fund Appropriation Act (No.1) 2013*, Department of Justice, representing a Recurrent appropriation.
 - (7) The sum of \$4 753 000 is to be applied to Division 7 of Part 2 of Schedule 1 to the *Consolidated Fund Appropriation Act (No.1) 2013*, Ministerial and Parliamentary Support, representing a Recurrent appropriation.

Clause 4 (cont.)

- (8) The sum of \$3 866 000 is to be applied to Division 8 of Part 2 of Schedule I to the *Consolidated Fund Appropriation Act (No.1) 2013*, Department of Police and Emergency Management, representing a Recurrent appropriation.
- (9) The sum of \$90 000 is to be applied to Division 9 of Part 2 of Schedule I to the *Consolidated Fund Appropriation Act (No.1) 2013*, Department of Premier and Cabinet, representing a Recurrent appropriation.
- (10) The sum of \$3 966 000 is to be applied to Division 10 of Part 2 of Schedule I to the *Consolidated Fund Appropriation Act (No.1) 2013*, Department of Primary Industries, Parks, Water and Environment, representing a Recurrent appropriation.

Clause 5

This clause provides for the expiry of the Act on 30 June 2015.
