Introduction

The Committee was appointed under the provisions of Section 3 of the *Subordinate Legislation Committee Act 1969* (No. 44 of 1969). Section 8 of the Act outlines the functions of the Committee, as follows –

- (a) to examine the provisions of every regulation, with special reference to the question whether or not –
 - (i) the regulation appears to be within the regulation-making power conferred by, or in accord with the general objects of, the Act pursuant to which it is made;
 - (ii) the form or purport of the regulation calls for elucidation;
 - (iii) the regulation unduly trespasses on personal rights and liberties;
 - (iv) the regulation unduly makes rights dependent on administrative decisions and not on judicial decisions; or
 - (v) the regulation contains matters that, in the opinion of the Committee, should properly be dealt with by an Act and not by regulation; and
- (b) to make such reports and recommendations to the Legislative Council and the House of Assembly as it thinks desirable as the result of any such examination.

COVID-19 DISEASE EMERGENCY (MISCELLANEOUS PROVISIONS) ACT 2020 – SCRUTINY OF NOTICES

The Parliament of Tasmania passed the COVID-19 Disease Emergency (Miscellaneous Provisions) Act 2020 (the Act) on 26 March 2020. The Act prescribes a role for the Joint Standing Committee on Subordinate Legislation in the scrutiny of certain notices under the Act.

In response to this new scrutiny role, the Committee has given extensive consideration to an appropriate mechanism for it to report upon its deliberations on all notices gazetted under the Act in the interest of public transparency. The Committee will:

- Meet twice weekly on Tuesdays and Fridays until further notice;
- Publish a list of the notices to be discussed by the Committee, and documentation relating to notices to be examined by the Committee, to be published on the Committee website prior to each meeting; and
- Present regular reports to Parliament, which will contain further information in relation to the completed examinations of notice.

Notice Under Section 19 (*Land Use Planning and Approvals Act 1993*)

The Committee received correspondence containing a package of information in relation to the Notice by correspondence of 4 May 2020. The Committee wrote to the Premier by correspondence of 5 and 13 May 2020 outlining a series of questions in relation to the Notice. A response was provided in writing by the Premier by correspondence of 15 May 2020.

At its meeting on 22 May 2020, the Committee concluded its examination of the Notice and **Resolved** the Notice be examined, noting that it was consistent with the *COVID-19 Disease Emergency (Miscellaneous Provisions) Act 2020* and the intent of the Parliament.

The supporting documentation provided by the Premier, along with further questions from the Committee and his response, and minutes of proceedings of relevant meetings are attached to this report for completeness.

Please find enclosed a copy of Notices issued by me as Premier pursuant to section 15 and 19 of the *COVID-19 Disease Emergency (Miscellaneous Provisions) Act 2020*.

The Notices were signed on 23 April 2020 and were published in the Gazette on 24 April 2020.

The Notices provide for the following:

1. **Protection from offences against planning law for certain emergency use and development for health services as necessary to effectively implement, or comply with, a requirement, direction or authorisation under the *Emergency Management Act 2006* or the *Public Health Act 1997* (Section 15 Notice)**

A number of health services are required to implement emergency use and development, usually in the form of temporary structures within the car parking areas adjoining the practice, so they can continue to consult, diagnose and treat patients during the COVID-19 emergency. There is also now a number of temporary COVID-19 testing pods located at Princes Wharf Shed No. 1 and the need to provide and urgent response to the health emergency in the north west of the State with the closure of the two hospitals in Burnie.

There are currently exemptions in planning schemes relating to emergency works, however, it is uncertain if this also provides for emergency use. The s.15 Notice aims to address this by providing clear protection from offences, including failure to obtain the normal planning permits, for emergency use and development related to health services during the emergency period if necessary for compliance with requirements under the *Emergency Management Act 2006* or the *Public Health Act 1997*.


2. **The public exhibition of certain documents required under the *Land Use Planning and Approvals Act 1993* (LUPAA) and the *Land Use Planning and Approvals Regulations 2014* (LUPA Regulations) to be undertaken in an alternate manner (Section 19 Notice).**

The majority of council offices are now closed to the public, which has implications for the public exhibition of documents for development applications, planning scheme amendments, and draft Local Provisions Schedules (LPSs) as LUPAA and the LUPA Regulations require the documents to be available for viewing at the council offices. The s.19 Notice provides alternative arrangements for public exhibition of documents for development applications and planning scheme amendments – documents may be viewed at the council's website or hardcopies can be made available on request for a fee.

The above approach of making hardcopies available on request is not feasible for draft Local Provisions Schedules due to the volume of documents, which also include a range of supporting reports. Discussions are continuing with LGAT and the Commission to determine if other alternative arrangements can be found for the exhibition LPSs, particularly those that are currently on exhibition and have had to stall due to the council offices needing to close.

I enclose a fact sheet to provide further information on the Notices and the Advice provided by the Office of Parliamentary Counsel (OPC) under section 7(2) of the *Subordinate Legislation Act 1992*.

NOTICE UNDER SECTION 15

I, PETER CARL GUTWEIN, the Premier, in pursuance of section 15(1) of the *COVID-19 Disease Emergency (Miscellaneous Provisions) Act 2020*, being of the opinion that the relevant emergency circumstances exist in relation to this notice and with the approval of the emergency manager, declare that a person does not commit an offence against the *Land Use Planning and Approvals Act 1993* ("the Act"), including an offence relating to the contravention of an existing planning permit issued, and in force, under the Act, in relation to an area of land, within the meaning of the Act, that is to be developed, or used, for the purposes of Hospital Services, medical centres or consulting rooms, as defined in the State Planning Provisions made under the Act, if the development, or use, of the land for such a purpose is necessary to effectively implement a requirement, direction or authorisation under the *Emergency Management Act 2006* or the *Public Health Act 1997*.



NOTICE UNDER SECTION 19

I, PETER CARL GUTWEIN, the Premier, in pursuance of section 19 of the *COVID-19 Disease Emergency (Miscellaneous Provisions) Act 2020*, being of the opinion that the relevant emergency circumstances exist in relation to this notice and with the approval of the emergency manager, declare that, despite any provision specified in the Schedule to this notice, a requirement specified in the provision for a document, or information, to be available for inspection, or displayed, is taken to be satisfied if –

- (a) the document, or the information, is –
 - (i) available, for viewing by members of the public, at a website of the relevant local council; or
 - (ii) available, in hard copy, on request by telephone and for a fee representing the cost of reproducing the document, either –
 - (A) for collection from a place nominated by an officer of the relevant council; or
 - (B) by posting the hard copy to the person who requested the copy; and
- (b) if submissions may be made in respect of the document or information, provision is made in accordance with section 80Q of the *Land Use Planning and Approvals Act 1993* for those submissions to be made, in addition to any other method, by an electronic method.

MINISTERIAL NOTICE - FACT SHEET

The attached draft Ministerial Notices are issued pursuant to sections 15 and 19 of the *COVID-19 Disease Emergency (Miscellaneous Provisions) Act 2020* (the COVID-19 Act). The State Controller has approved the issuing of the Notices, as required under section 6 of the Act.

Reasons for Notice(s)

The Tasmanian Government has been working closely with the local government sector, through the Local Government Association of Tasmania (LGAT), to identify priority business continuity and regulatory compliance challenges for Tasmanian councils associated with the COVID-19 pandemic emergency, particularly in relation to the current restrictions on the movement of council elected members and staff and the need to close council offices to the public.

The key areas that need to be addressed include:

- providing for protection from planning offences, such as failure to get a planning permit under the *Land Use Planning and Approvals Act 1993* (LUPAA) for certain emergency use and development for health services during the emergency period; and
- providing alternative arrangements for the public exhibition of documents relating to development applications and planning scheme amendments under LUPAA and the associated regulations.

The Premier considers that the issuing of the attached Notices is necessary to effectively manage immediate business continuity and statutory compliance risks for the local government sector, consistent with objectives of the COVID-19 Act and that the emergency circumstances specified in sections 5(2)(a), 5(2)(b), 5(2)(c), and 5(2)(e) of the COVID-19 Act exist in relation to the Notices.

Consultation with the local government sector regarding business and service continuity during the pandemic emergency is ongoing.

Effect of Notice(s)

The Ministerial Notices provide for the following:

Thank you for your letters of 5 May 2020 and 13 May 2020 seeking clarification on the following questions.

1. How many Councils have completed the public exhibition and consultation process on their LPSs?

Six (6) draft LPSs have completed the public exhibition process – Meander Valley, Brighton, Central Coast, Burnie, Glamorgan Spring Bay, and Clarence.

2. How many Councils are in the process of the public exhibition and consultation on their LPSs?

Two (2) draft LPSs have commenced the process of public exhibition, but are yet to be completed – Circular Head and Devonport.

3. How many Councils are anticipated to begin the public exhibition and consultation process on their LPSs during the emergency period?

It is difficult at this point to determine how long the emergency period will run for. There are likely to be at least five (5) draft LPSs publicly exhibited in the next six (6) months based on current estimates, comprising two (2) draft LPSs and the substantial modifications of three (3) draft LPSs. There are several other draft LPSs anticipated to begin exhibition based on current estimates.

4. In relation to those Councils that have completed the public exhibition process on their LPSs, how often were LPSs requested for viewing in person prior to the COVID-19 restrictions being imposed?

The Department is unable to provide any exact details on how often people view draft LPSs in person at the Council offices. Anecdotally, some Councils have identified that some people visit the Council offices, or phone the Council, for guidance on how to access the documents that are available on their website. Most then view the documents on the Council's website. However, there are people in Tasmania who have limited or no personal internet access, so would rely on viewing the documents at the Council's offices, or through other public access points such as libraries.

5. What progress has been made in discussion with LGAT and the Commission regarding the process to facilitate public viewing of LPS's?

Good progress has been made to identify options for the public to view draft LPSs if they are unable to access the electronic version of the documents that are already required to be made available on the Council's (and the Commission's) website under the *Land Use Planning and Approvals Act 1993*. A draft notice under section 19 of the *COVID-19 Disease Emergency (Miscellaneous Provisions) Act 2020* is currently being prepared to provide for an alternate 'approved manner' for the documents to be publicly exhibited if a Council (or the Commission) office is closed.

6. For those LPS's currently on exhibition prior to the COVID-19 restrictions that have stalled due to Council offices needing to close, will they be progressed prior to any alternative mechanism for public exhibition has been established?


Public exhibition of the draft LPSs is unable to be continued if a Council office is closed. Sections 35C(4) and 35D(1) of the *Land Use Planning and Approvals Act 1993* specifically requires a copy of the relevant draft LPS exhibition documents to be available for viewing at Council offices during the 60 day public exhibition period. For the public exhibition period to continue, the council offices would need to reopen to the public, or a notice would need to be issued in accordance with Section 19 of the *COVID-19 Disease Emergency (Miscellaneous Provisions) Act 2020* to provide an 'approved manner' for the exhibition documents to be viewed, for the remainder of the exhibition period.

7. For Councils that embark on the public exhibition and consultation process on their LPSs during this time, how will effective communication with the community and transparency in relation to the adjusted consultation processes be achieved?

While Council offices may be closed to the public, Council staff continue to work and are able to advise the community on the draft LPS while on public exhibition. People will be able to call or email Council planning staff to seek assistance with viewing the documents and answer any questions they may have. A Council is required to issue a public notice in accordance with the *Land Use Planning and Approvals Act 1993*, which must be published in a newspaper that circulates generally in Tasmania, once before the commencement of the exhibition period and again within 14 days of the first notice. The public notice must outline the period of public exhibition, where the relevant exhibition documents can be viewed, and invite people to make representations and specify where they are to be submitted. Councils that are part way through public exhibition of their draft LPS, will be required to publish a new public notice outlining the alternative ways that the relevant exhibition documents can be viewed before re-commencing the exhibition period.

The Commission will work closely with those Councils impacted by office closures due to COVID-19 to ensure effective communication to the community. The draft LPS relevant exhibition documents are also required to be made available on the Commission's website and the Commission's offices during the exhibition period. At present there are no issues with viewing documents at the Commission offices.
