Inquiry into the Tasmanian Government's process into the proposed Arts, Entertainment and Sports Precinct in Hobart

The Parliamentary Standing Committee of Public Accounts (Committee) is continuing its targeted inquiry into the Tasmanian Government's process into the planning for the proposed Arts, Entertainment and Sports Precinct in Hobart.

The Committee is considering amongst other factors: matters related to the Club Funding and Development Agreement (Agreement) signed between the Crown in the Right of Tasmania and Australian Football League; the suitability of Macquarie Point as the site for a proposed the Arts, Entertainment and Sports Precinct; the financial risks associated with the Agreement; matters related to the financing and delivery of the entire proposed Arts, Entertainment and Sports Precinct; the future of Blundstone Arena and UTAS Stadium; and any other incidental matters.

The Committee will conduct a public hearing to obtain further details from submissions to the Inquiry.

The hearings will be held in Committee Room 2, Parliament House, Hobart and will commence at 2:00 pm on Friday, 23 June 2023. The timetable and details of witnesses are attached.
