A BILL FOR

An Act to amend certain Acts consequentially on the enactment of the *Irrigation Company Act 2011*

Be it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

1. Short title

This Act may be cited as the *Irrigation Company (Consequential Amendments) Act 2011*.

2. Commencement

- (1) Except as provided in this section, this Act commences on the transfer day, within the meaning of the *Irrigation Company Act 2011*.
- (2) Section 4 and Schedule 2 commence on the day on which the *Rivers and Water Supply Commission Act 1999* is repealed by
