## WEDNESDAY, 23 MAY 2018

**1 COUNCIL MEETS.**— The Council met at 11.00 o'clock in the forenoon and the President read Prayers.

- 2 **PAPERS.** The Clerk of the Council laid upon the Table the following Papers:—
  - (1) Department of Justice: Fees set in accordance with the Fee Units Act 1997 to apply from 1 July 2018.
  - (2) Pollution of Waters by Oil and Noxious Substances Act 1987: Statutory Rules 2017, containing Pollution of Waters by Oil and Noxious Substances Regulations 2017.
  - (3) Environmental Management and Pollution Control Act 1994: Statutory Rules 2018, containing Environmental Management and Pollution Control (Distributed Atmospheric Emissions) Regulations 2018.
  - (4) Tasmanian Water and Sewerage State of the Industry Report 2016-17, April 2018, Office of the Tasmanian Economic Regulator.
  - (5) Aurora Energy: Members' Direction to Aurora under Article 24.4 to fund and distribute a one-off "Special Energy Bonus" payment of \$125 to eligible Aurora Energy electricity customers during the 2017-18 financial years.
  - (6) Marine and Safety Tasmania: Fees set in accordance with the Fee Units Act 1997 to apply from 1 July 2018.
- **3 BILL NO. 3.** The Order of the Day was read for the Second reading of the Tasmanian Health Service Bill 2018.

A Motion was made (Mrs *Hiscutt*), and the Question was proposed, That the Bill be now read the Second time.

A Debate arose thereupon.

And the Question being put,

It was resolved in the Affirmative.

And the Bill was, accordingly, read the Second time and committee to a Committee of the Whole Council.

And the President having left the Chair, the Council resolved itself into the said Committee.

Clauses 1 to 18 agreed to.

4 **SITTING SUSPENDED.**— It being 1.00 o'clock p.m. the Sitting of the Council was suspended.

The Council resumed the Sitting at 2.30 o'clock p.m.

**5 QUESTION TIME.**— The President called for Questions without Notice. There were eight Questions asked.

**6 LEAVE TO TABLE ANSWER TO QUESTION AND INCORPORATE ANSWER INTO HANSARD.**— *Ordered,* That Mrs *Hiscutt* have leave to Table the answer to the Question without Notice asked by Ms *Rattray* in relation to bikes on towbar racks obscuring vehicle number plates and have the answer incorporated into the Hansard.

**7 BILL NO. 3.**— The Council, according to Order, again resolved itself into a Committee on the Tasmanian Health Service Bill 2018.

(In the Committee)

Ms Forrest in the Chair.

Clauses 19 to 21 agreed to.

Ms Rattray in the Chair.

Clause 22 to 27 agreed to.

Clause 28, Amendment made. (Ms Forrest)

Page 30, after paragraph (d).

Insert the following paragraph:

(x) to monitor and report to the Secretary on the outcomes, for persons, of the provision of health services to those persons; and

Clause as amended, agreed to.

Clauses 29 to 30 agreed to.

Ms Forrest in the Chair.

Clauses 31 to 43 agreed to.

Schedule 1 and 2 agreed to.

Title agreed to.

Bill to be reported with Amendment.

The Council being resumed, Ms *Forrest* reported that the Committee had gone through the Bill, and directed her to report the same to the Council with Amendment.

*Ordered*, That the Third reading of the Bill as amended in Committee be made an Order of the Day for tomorrow. (Mrs *Hiscutt*)

**8 ADDRESS-IN-REPLY.**— The Order of the Day was read for resuming the Debate on the Question that the Address-in-Reply to Her Excellency the Governor's Speech be agreed to. (Mrs *Hiscutt*)

The Question was again proposed, and the Council resumed the Debate.

Ordered, That the Debate be adjourned. (Ms Forrest)

**9 ADJOURNMENT.**— A Motion was made (Mrs *Hiscutt*) and the Question was proposed, That the Council will at its rising adjourn until 11.00 o'clock am on Thursday, 24 May 2018. (Mrs *Hiscutt*)

And the Question being put,

It was resolved in the Affirmative.

Resolved, That the Council do now adjourn. (Mrs Hiscutt)

The Council adjourned at 6.02 o'clock am.
