A Bill for an Act to amend the *Children, Young Persons and Their Families Act 1997*, the *Commissions of Inquiry Act 1995*, the *Public Interest Disclosures Act 2002* and the *Youth Justice Act 1997*
Justice Miscellaneous (Commissions of Inquiry) Bill 2021
(Bill No 6 of 2021; *Act No 4 of 2021*)

having been presented to the Governor for the Royal Assent, she has, in the name of Her Majesty the Queen, assented to the said Bills.
