re: Inquiry : Palliative Care Patients.

Thankyou for the opportunity to comment upon the issues to be addressed by the Inquiry.

This submission deals with two generalities related to the terms of reference.

1. The importance of local and home care and support of patients.

There is probably academic data relating to local and home care; however, it is my observation over decades that patients prefer family and local care to institutionalised care. More recent cases involved patients suffering MND and Parkinson's Disease.

My observations have been that patients value care in their own home, particularly when much of that care is provided by family and friends. That is not to devalue the visits by professional health and allied health practitioners.

However, it is not just the care provided by family living out the final years of their life, or recovering at home means patients:-

- (a) remain as long as possible in their familiar surroundings;
- (b) remain (easily) accessible to friends and neighbours;
- (c) have 24/7 moral and physical support from those near and dear to them.

Older people are also able to live in familiar surroundings.  
Children and juveniles also prefer to be in familiar surroundings.

This is not to say that visits by health care workers are not valuable; they are! Further those visits should continue, and be extended, particularly in rural areas.

## 2. Services in (some) rural areas in Tasmania.

Over the past half century some rural towns have missed out on many government and quasi-government services. One of those centres is Westbury.

Westbury's current town population is about 2200 to 2300. (There are almost exactly 1000 mail boxes, which serves as a base to calculate the town population).

Unlike many similarly-sized or smaller population centres (e.g. Scottsdale, St. Helens, St. Marys, St. Helens, Swansea, Deloraine, Sheffield, Beaconsfield, Lilydale, Longford, Cressy, Campbell Town, Oatlands, ---) Westbury lacks many facilities one might expect in a town of 2200+ and a population of about 9500 within a 20 km radius. Westbury has no secondary / post secondary / vocational education facilities, no (rehabilitation / community) swimming pool, no local hospital, --- and no aged care / rehabilitation facilities.

The lack of such aged care / rehabilitation facilities forces aged and ill community members to leave their home community. Similarly the Westbury community "loses" its young people at the end of year 6.

Community development should involve the whole community - "from cradle to grave."

In the case of Westbury, I would encourage government assistance to move towards establishment of facilities at Westbury, consistent with the suite of facilities in similarly-sized, and smaller communities.

Specifically, in relation to Westbury, assistance will be needed to upgrade and establish aged care / rehabilitation / palliative care, and other facilities.
