

Children's Dental Services

For children's dental services, Oral Health Services Tasmania (OHST) produces an annual report detailing dmft/DMFT ratings within Local Government Areas for children who attended an OHST clinic. dmft stands for (d) decayed, (m) missing, (f) filled (teeth). The lower the dmft, the better the health status. While the maps below are a snapshot on 2021, OHST also looks at trends over time at a statewide level. The graphs below the maps show the improvements being made in children's oral health in Tasmania over several years. Note that it is not possible to accurately assess trends over time at an LGA level due to small population sizes.

Mean dmft of children at 6 yrs examined at OHST - 2021





Mean DMFT of children at 12 yrs examined at OHST - 2021


