

## FISHERMEN.

PETITION FOR SEINE FISHING ON THE RIVER DERWENT AS FAR NORTH AS RISDON.

Laid upon the Table by the Colonial Treasurer, and ordered by the House to be printed, December 6, 1871.



To His Excellency CHARLES DU CANE, Esquire, Administrator of the Government of Tasmania and its Dependencies, and the Honorable the Members of the Executive Council.

The humble Memorial of the undersigned Seine Fishermen and others the Inhabitants of Hobart Town, on their behalf, praying for an alteration of the boundary line at present in force under the 22nd clause of "The Salmon Fisheries Act."

Youn Petitioners, more especially the Seine Fishermen and the Hawkers of Fish, would respectfully urge that in lieu of the present line of boundary that Risdon Ferry be constituted such boundary line in the River Derwent, thereby opening up to your Petitioners ground for their calling that has been closed to them for many years, and which they believe would not be detrimental to the preservation of the Salmon.

A great boon would be conferred on the Inhabitants of Hobart Town generally by such an alteration in the boundary, inasmuch as fish of the description required is mostly to be caught in the numerous small bays betwixt Hobart Town and Risdon, at present closed; and a plentiful supply of fish might be expected daily in place of the present scarcity.

In rough weather, such as has been the case for some months, your Petitioners (the Seine Fishermen) are debarred from exercising their calling below the City, and their wives and families have suffered great hardships from the deprivation of their former privileges; and your Petitioners generally would respectfully submit that as nearly seven years have elapsed from the passing of "The Salmon Fisheries Act," it is time that some alteration should be made in the boundary line as prayed for by your Petitioners.

In conclusion, your Petitioners respectfully beg to point out that the Fish Hawkers, a numerous and hard-working class of the community, are mainly dependent for many months of the year on the seine fishery for their daily supply of fish; and that, from the great scarcity that has long existed, they are compelled morning after morning to leave the market without being able to procure a supply for their customers, thereby reducing their wives and families at this, the most inclement season of the year, to a state of semi-starvation and wretchedness.

Humbly trusting that Your Excellency in Council will take their case into your kindest consideration, Your Excellency's Petitioners, as in duty bound, will ever pray.
