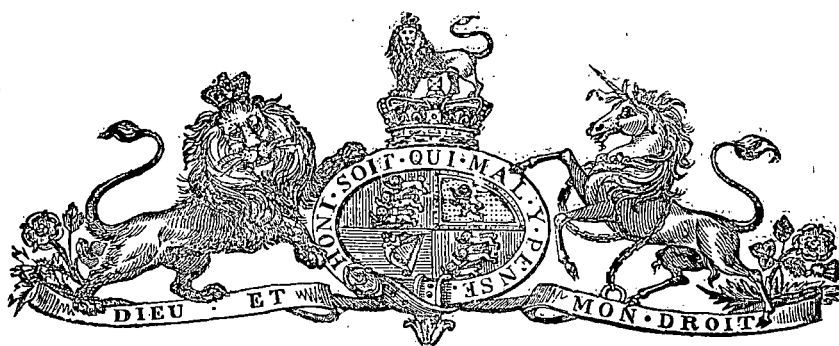

R E P O R T.

1. THE Trustees, in presenting their Third Annual Report, have much pleasure in announcing that the average attendance of visitors is still maintained, from which it may be inferred that the usefulness of the Institution is still fully appreciated. During the past year 28,937 persons have registered their names in the Visitors' Book. This does not, however, represent the total number who have visited the Institution during that period, inasmuch as a very large number of persons neglect to register their names.

2. During the year 102 volumes have been added by purchase, 78 volumes by presentation, and 1 volume recovered of those missing from the old Library,—making in all an addition of 181 volumes besides pamphlets, &c.

The Trustees have to acknowledge with thanks the receipt of donations from His Excellency Charles Du Cane, Esquire, Governor of Tasmania; the Government of Tasmania; the Tasmanian Board of Education; the Government of Victoria; the Registrar-General of Victoria; the Exhibition Commissioners, Melbourne; the Deaf and Dumb Institution of Melbourne; the Government of New South Wales; the Government of New Zealand; the Registrar-General of that Colony; the New Zealand Institute; the Trustees of the British Museum; the Royal Geographical Society; the Brigadier-General, War Department, Washington; the Colonial Secretary, British Columbia; also the late Librarian of the Tasmanian Public Library; Messrs. W. L. Richardson, A. W. Birchall, A. C. Douglas, P. T. Smith, E. C. Nowell, J. W. Agnew, — Morrel, Miss White, and the Rev. R. D. Harris. Contributions have also been received from "Irish gentlemen resident in Tasmania" and "Cambrian residents in Tasmania."

* There is a still further balance due to Walch & Sons, on account of former liability, for binding of £15, together with other outstanding liabilities for 1873, amounting in all to a total sum of £24 2s. 1d. for which provision has to be made.

MEMORANDUM.

On the 30th June, 1874, the Trustees paid to the Colonial Treasurer the sum of one hundred and one pounds for a Government Debenture for one hundred pounds, bearing interest at the rate of five per cent. per annum, and redeemable on the 1st of December, 1878.

The invested funds now amount to one thousand five hundred pounds in Government Debentures, namely,—one thousand four hundred pounds bearing interest at six per cent. per annum, redeemable on the 30th of December, 1877, and one hundred pounds bearing interest at five per cent. per annum, redeemable on the 1st of December, 1878, together producing an annual revenue of eighty-nine pounds; and from that income the sum of seventy-five pounds is annually paid over by the Trustees of the Library to the Municipal Council of Hobart Town in aid of the salary of the Librarian.
