- 2 PRAYERS. The Speaker read Prayers.
- **3** QUESTIONS SEEKING INFORMATION. In accordance with Standing Order No. 43, Questions without notice commenced.
- 4 DISTINGUISHED VISITOR. The Speaker said "I would like to draw to the attention of Honourable Members to the presence in the Speaker's Reserve of Mr Peter Slipper, Former Speaker of the House of Representatives."
- **5** QUESTIONS SEEKING INFORMATION. In accordance with Standing Order No. 43, Questions without notice continued and concluded.
- 6 PAPERS. The Deputy Premier laid upon the Table of the House the following Paper:-

Heavy Vehicle National Law and Other Legislation Amendment Act 2018: Act No 10 of 2018.

7 BILL NO. 27. – The Minister for Building and Construction presented -

A Bill for an Act to amend the Building Act 2016, the Occupational Licensing Act 2005, the Building Regulations 2016, the Occupational Licensing (Building Services Work) Regulations 2016, the Residential Building Work Contracts and Dispute Resolution Regulations 2016, and the Urban Drainage (General) Regulations 2016

And Mr *Barnett* having presented the said Bill, the same was read the First time and made an Order of the Day for tomorrow.

8 BILL NO. 29. – The Minister for Police, Fire and Emergency Management presented -

A Bill for an Act to amend the Listening Devices Act 1991, and the Police Powers (Surveillance Devices) Act 2006, to allow for the use of cameras worn or held by police officers

BILL NO. 12. - A Message to the Legislative Council. -

MR PRESIDENT

The House of Assembly hath passed a Bill, intituled "A Bill for an Act to provide for the appointment and duties of justices, for the issuing of a code of conduct that applies to justices, for the suspension and revocation of the appointment of justices, for the use of titles by justices and retired justices and for related purposes",

to which the House desires the concurrence of the Legislative Council.

- 15 LAW AND ORDER. A Motion being made and the Question being proposed—That the House:—
  - (1) Condemns the Labor Party for its persistent weakness on law and order issues, and its resulting failure to stand up for the community and victims.
  - (2) Notes Labor has learned nothing from its third worst election defeat in March 2018, and has stood by its flawed policies to oppose mandatory minimum sentences for people who commit serious sexual offences against children; to oppose mandatory prison time for those who seriously assault off duty police officers, and also to oppose measures that would protect frontline workers from serious assaults and impose a guaranteed prison sentence for such offenders.
  - (3) Further notes that Labor's soft on crime position to oppose measures to protect Tasmanians from Outlaw Motorcycle Gangs is typical of an opposition that has no policies and has no plans for Tasmania.
  - (4) Calls on the Labor party to get their priorities right, to stand up for the community, the rights of victims and finally support the Government's law and order agenda. (Mr *Brooks*)

A debate arose thereupon.

And the Question being put;

It was resolved in the Affirmative.

- 16 CODE OF CONDUCT FOR MEMBERS. A Motion being made and the Question being proposed—That the House:—
  - (1) Notes the Code of Conduct for Members of Parliament of Tasmania Report No. 2 at the Joint Standing Committee on Integrity.
  - (2) Accepts the recommendation that: "A comprehensive Code of Conduct, with reference to the Integrity Commission's 2016 Draft Code of Conduct, is pursued as a matter of priority in the next term of government with a view of implementing a comprehensive code for Members of Parliament in both Houses by the end of 2018." (Ms White)

A debate arose thereupon.

And the Question being put;

It was resolved in the Affirmative.

- 17 PLANNING SCHEME. A Motion being made and the Question being proposed—That the House:—
  - (1) Acknowledges the unprecedented assault on the Tasmanian environment, public lands and communities caused by the Liberals' pro-developer planning scheme changes and 'open for business' mantra'.
  - (2) Agrees that public consultation and appeal rights must be enshrined in all planning assessments and decisions.
  - (3) Rejects any move to enact Major Projects legislation and further degrade the public interest in land use planning.
  - (4) Supports an independent planning system for Tasmania. (Ms O'Connor)
