## **SOUTHERN OUTLET TRANSIT LANE**

Dear Mr Hennessy,

I refer to your email of the 10 October 2022 requesting further information in relation to the *Parliamentary Standing Committee for Public Works* hearing of the 4 October 2022.

I note that there are four questions raised and respond as follows:

• The policy document prepared for the Department of State Growth (by a subject matter expert) on utilisation and location of park and ride facilities;

Attached to this email is a copy of the requested policy document on utilisation and location of the park and ride facilities (*Greater Hobart Park and Ride Investigation Strategic Planning Guidelines, November* 2019).

• A hydrology report for the works specifically, if available, or a more general hydrology report for the Southern Outlet, including the area of the works, if available;

An hydrology report has not been prepared for this project at this stage however a section reporting on the hydrology of the site will be contained in the final design report, which will not be available until the detailed design is finalised in coming months.

• Data on the number of heavy vehicle movements on the Southern Outlet between 7am-9am.

The total number of heavy vehicles on the Southern Outlet between 7:00am and 9:00am is 723, with 408 and 315 on the northbound (Hobart bound) and southbound (Kingston bound) lane respectively. These figures are the weekday average across each month in 2021. The average total weekday traffic between these hours in 2021 is 7265, with 4994 (northbound) and 2271 (southbound) respectively.

<sup>\*723</sup> represents the combined figure for rigid and articulate trucks.

Rigid trucks are heavy vehicles under 12.5m in length. Examples are buses, garbage trucks and delivery trucks. Articulated trucks can be up to 25m in length. Examples of articulated trucks are semi-trailers, B-double trucks and articulated buses.

Further breakdown of the heavy vehicle volume based on the classes of vehicles can be provided upon request.
