**12** SUSPENSION OF STANDING ORDERS. – A Motion being made - That so much of Standing Orders be suspended as would prevent the following motion from being brought on for debate forthwith.

That the House censures *Dean Winter* MP on the following grounds:

- (1) Since abandoning Labor’s opposition to the stadium after the 2024 election, Mr *Winter* has consistently said that the stadium’s cost to the State needs to not exceed \$375 million, and that Labor will scrutinise the stadium in detail and hold the Government to account.
- (2) Subsequently Mr *Winter* called for the Government to fast-track approving the stadium before the State Budget, bypassing current assessment and scrutiny processes.

## UNCORRECTED PROOF

- (3) Mr *Winter* has now made it clear that Labor will vote to approve the stadium regardless of the cost to the Tasmanian taxpayers, the impacts on the city, and without and credible planning assessment that involves community engagement.
- (4) Mr *Winter* has betrayed his Party's commitments during the 2024 election, his subsequent commitments to the people of Tasmania, as well as his responsibilities as Leader of the Opposition. (Dr *Woodruff*)

A Debate arose thereupon.
