43 Mr *Garland* to move—That the House:—

(1) Notes:—

- (a) Marinus Link Stage 1, including the North West Transmission Development Stage 1, is the biggest public infrastructure project in the State's history and will cost well in excess of \$5 billion;
- (b) Marinus Link will significantly increase electricity prices for all Tasmanians, particularly our major industrials;
- (c) Marinus Link will add billions of dollars of debt to our already unsustainable budget deficit;
- (d) the whole of state business case, produced by Treasury to provide a comprehensive analysis of Marinus Link, highlights the many significant risks it poses to Tasmania, but much of the detail is redacted. An unredacted version of the business case still has not been released to the public or MPs;
- (e) the Marinus Link Agreement was signed by the Minister for Energy and Renewables, Hon. Nicholas Duigan MLC, while the Government was in caretaker mode, prior to public release of the whole of state business case; and
- (f) the Joint Select Committee on Energy Matters (Energy Committee) has been looking closely at Marinus Link and other energy policy matters for 18 months.

(2) Calls on the Government to stop the North West Transmission Development until after:—

- (a) Treasury provides a fully considered and publicly available report on a 'No Marinus' scenario for our energy system in Tasmania; and
- (b) the release of the final report by the Energy Committee. (2 December 2025)
