No. 11 TUESDAY, 21 MAY 2019

- 1 **COUNCIL MEETS.** The Council met at 2.30 o'clock in the afternoon.
- **ELECTION OF PRESIDENT.** The Honourable *Tania Verene Rattray*, Member for McIntyre, addressing herself to the Clerk, proposed to the Council for their President the Honourable *Craig Maxwell Farrell*, Member for Derwent, and moved "That the Honourable *Craig Maxwell Farrell* do take the Chair of this Council as President"; which Motion was seconded by the Honourable *Leonie Anne Hiscutt*, Member for Montgomery.

There being no further nominations Mr *Farrell* stood in his place, and expressed the sense he had of the honour proposed to be conferred upon him, and submitted himself to the Council.

The Council then called Mr Farrell to the Chair.

Mr Farrell was then taken out of his place by the said Ms Rattray and Mrs Hiscutt and conducted to the Chair, where, standing on the upper step he returned his humble acknowledgement to the Council for the great honour they had been pleased to confer upon him by choosing him to be their President; and thereupon he took the Chair.

3 ACKNOWLEDGEMENT OF TRADITIONAL PEOPLE.— It being the first day of the Budget session the President said: —

"We acknowledge the traditional people of the land upon which we meet today, the Mouheneener People."

- 4 **PRAYERS.** The President read Prayers.
- **5** WRITS FOR THE RETURN OF NEW MEMBERS.— The Clerk of the Council laid upon the Table of the Council writs for the return of new Members for the Electoral Divisions of Pembroke, Montgomery and Nelson and, certifying to *Joanna Clare Siejka*, *Leonie Anne Hiscutt* and, *Megan Therese Webb* respectively, having been chosen on the 4th day of May 2019 to serve in the Legislative Council.
- 6 AUTHORIZATION TO ADMINISTER OATH OR AFFIRMATION.— The Clerk of the Council said:—

"With the authority of a Proclamation issued by the Governor in accordance with Section 30 of the *Constitution Act 1934* I am duly authorised to administer the Oath of Allegiance or Affirmation as prescribed by the *Promissory Oaths Act 2015*".

Mr President, I advise the Council that Joanna Clare Siejka returned upon a new writ for Pembroke and Leonie Anne Hiscutt returned upon a new writ for Montgomery have earlier today made and taken the Affirmation and Oath of Allegiance respectively as required by Law".

7 **NEW MEMBER FOR NELSN SWORN.**—*Megan Therese Webb* returned upon a new Writ for Nelson made the Affirmation required by law.

8 STATEMENT BY THE PRESIDENT – WELCOME NEW MEMBERS.— The President said —

"I take this opportunity to welcome to this House and the Parliament the newly elected Member for Nelson and wish her well in her role representing the people that have duly elected her.

I know that I speak on behalf of all Members, Chamber Officers and staff when I say we are ready to offer any support, advice or assistance that you may require, particularly in the early stages of your elected term. Please do not hesitate to ask. You will find, I am sure, that your role at times will be challenging but know you can be assured that you will find it satisfying and rewarding as you now get not only the opportunity to assist and represent the people of your Nelson electorate here in the Legislative Council but to also contribute to the improved welfare of the people of Tasmania.

I extend a warm welcome to you.

Also, I wish to acknowledge and congratulate the Honourable Members for Pembroke and Montgomery on their return to this Chamber and I know that both Honourable Members will continue to work extremely hard for the people of their respective electorates and Tasmania and we look forward to your further contributions in this Parliament."

9 STATEMENT BY THE PRESIDENT – CHAMBER REFURBISHMENT PROJECT.— The President said:—

"Honourable Members it is obvious to all that the working environment in the Chamber has undergone modification since the Quorum Call on 3 May. The planned Stage Two works have been undertaken and completed by our principal contractors, Voss Constructions, the Contact Mechanical Services Group and Degree C who have installed new lighting and other electrical services.

This completes the Chamber refurbishment with the exception of several ergonomic task chairs which are scheduled for delivery at the end of this month. I have no doubt that the results represent a vast improvement on the environment in which Members and our officers have previously had to work.

There is no doubt that the project had its challenges given the very sensitive and unique heritage value of the Chamber and the space in which our Architect, Mr David Button from Jaws Architects had to work. I believe he has executed his brief very well and I congratulate him and his Design Assistant, Laura Stucken, on their fine work. I also congratulate and acknowledge all of the contractors who have contributed to the end result including, Garrett Leitch from Voss; Brandon Servant – Project Engineer and Terence Ling - Building Services Engineer from Andrew Sutherland Consulting Engineers; Gary Collins – Project Manager from Degree C and his team; Micky Gelormini from Rehab Upholstery; and Stuart Hamilton and Landon Bannister from Southern Lighting. All have been thoroughly professional in their respective roles.

I want to also extend thanks to Peter Hancox, Brett Godfrey and Chris Machin from our own ICT unit for their input throughout the project. Their technical skill and expertise has been invaluable.

I want to finally acknowledge and thank Simon Carter from Voss Constructions who worked on this project physically in the Chamber from day one often from sun up to sun down. His efforts have gone a long way in enabling the delivery of the refurbishment on time.

I well understand that the new seating and desk arrangements will take a little getting used to, however I do look forward to Members and Chamber Officers being able to undertake your work in this Chamber in much improved conditions."
