We acknowledge and pay respect to the Tasmanian Aboriginal people and elders, past, present and emerging. We recognise them as the traditional and original owners and the continuing custodians of this land."

29 BILL NO. 30.— The Order of the Day was read for the further consideration in Committee of the End-of-Life Choices (Voluntary Assisted Dying) Bill 2020.

And the President having left the Chair, the Council resolved itself into the said Committee.

Ms Forrest in the Chair.

New Clauses C and D [Voluntary Assisted Dying Commission and Meetings of Commission] brought up (Ms *Lovell*) and read the First time as follows:—

B. Voluntary Assisted Dying Commission

- The Voluntary Assisted Dying Commission (the Commission) is established by this subsection.
- (2) The Commission consists of
 - (a) a person who is an Australian lawyer of not less than 7 years' standing as an Australian legal practitioner and who is to be the chairperson of the Commission and the Executive Commissioner; and
 - (b) a person, who is to be the Deputy Executive Commissioner; and
 - (c) at least 3 other members as may be necessary for the proper functioning of the Commission.
- (3) The members of the Commission are to be appointed jointly by the Minister and the Attorney-General.
- (4) A member of the Commission is entitled to be paid
 - (a) the remuneration fixed from time to time by the Governor; and
 - (b) the travelling and other allowances that are fixed from time to time by the Governor.
- (5) A member of the Commission
 - (a) may hold the office in conjunction with State Service employment;but
 - (b) is not appointed to the office of member subject to and in accordance with the *State Service Act 2000*.
- (6) The Deputy Executive Commissioner is to act as the Executive Commissioner during any period when the Executive Commissioner is absent from duty or from the State.

C. Meetings of Commission

- Meetings of the Commission may be convened by the Executive Commissioner or by any 2 members of the Commission.
- (2) Three members of the Commission form a quorum at any duly convened meeting of the Commission.
- (3) A question arising at a meeting of the Commission is to be determined by a majority of votes of the members of the Commission present and voting at the meeting.

- (4) The Executive Commissioner is to preside at all meetings of the Commission.
- (5) If the Executive Commissioner is not present at a meeting of the Commission, a member of the Commission elected by the members present is to preside at that meeting.
- (6) The procedure for the calling of, and for the conduct of business at, meetings of the Commission is to be determined by the Commission.

New Clauses C and D read the Second time.

Amendment made. (Mr Gaffney)

New Clause C, proposed subclause (2), proposed paragraph (a).

Leave out "who is an Australian lawyer of not less than 7 years' standing as an Australian legal practitioner and".

New Clause C as amended and New Clause D made part of the Bill (to follow Clause 108 in Part 17).

To report progress and seek leave to sit again.

The Council being resumed, Ms *Forrest* reported that the Committee had made progress in the Bill, and that she was directed to move that the Committee may have leave to sit again.

Resolved, That the Council will, tomorrow, again resolve itself into the said Committee.
