- 1 The House met at Ten o'clock a.m.
- 2 ACKNOWLEDGEMENT OF TRADITIONAL PEOPLE. The Speaker made a statement acknowledging the traditional people of the land.
- 3 PRAYERS AND REFLECTION. The Speaker read Prayers.
- **4** SPEAKER'S STATEMENT: MISREPRESENTATION OF OFFICIAL PROCEEDINGS. The Speaker made the following statement:

"It has been brought to my attention that there have been a number of instances of the official broadcast being edited or doctored and placed on social media. This is a misrepresentation of the proceedings of the House because the clips no longer represent a true account of the proceedings of the House.

I refer Members to *Erskine May's Parliamentary Practice* which the previous Speaker, Mr *Shelton*, reminded the House of. It states that "deliberate or reckless misrepresentation of the House's proceedings remains a contempt and is unlikely to attract qualified privilege. This principle also applies to the posting of online clips of proceedings which are misdescribed or out of context".

I note that putting a disclaimer at the end of a post in no way changes the risk of breaching Parliamentary privilege.

Incidents such as this will be a matter for the House to pursue."
