A Bill for an Act to amend the Justices Act 1959 and other justice-related legislation (Bill No. 60 of 2021 (Act No. 2 of 2022))

A Bill for an Act to amend the Living Marine Resources Management Act 1995 (Bill No. 58 of 2021 (Act No. 3 of 2022))

A Bill for an Act to amend the Criminal Code Act 1924 (Bill No. 50 of 2021 (Act No. 4 of 2022))

having been presented to the Governor for the Royal Assent, she has, in the name and on behalf of Her Majesty the Queen, assented to the said Bills.

6 BILL NO. 54 of 2021. - A Message from the Legislative Council -

The Legislative Council has this day agreed, without Amendment, to a Bill, intituled - "A Bill for an Act to establish a container refund scheme to reduce litter in Tasmania and increase the recovery and recycling of containers".

9 BILL NO. 11. – The Minister for Workplace Safety and Consumer Affairs presented -

"A Bill for an Act to regulate electricity infrastructure, electrical installations, electrical equipment, and certain activities near electricity infrastructure and electrical installations; to provide for safety and related technical standards that ensure that the electricity infrastructure, electrical installations and electrical equipment are safe, designed, maintained and managed in a manner that protects persons and property; to amend the Electricity Supply Industry Act 1995; to repeal the Electricity Industry Safety and Administration Act 1997 and for related purposes".
