- **1 COUNCIL MEETS.** The Council met at 11.00 o'clock in the forenoon and the President read Prayers.

4 LEAVE TO MAKE A STATEMENT: SELECT COMMITTEE FIREARMS REFORMS.—Ordered, That Mr Dean have leave to make a statement.

5 STATEMENT: SELECT COMMITTEE FIREARMS REFORMS.—Mr Dean said —

"Mr President, my statement today relates to the proposed firearms law reform inquiry. The Legislative Council Select Committee inquiring into proposed firearms law reforms, having been placed in its current position by the Government's decision not to progress the previously announced firearms law proposals, has determined to provide a report to the parliament setting out the circumstances in reaching this stage.

The report will include a copy of the 110 submissions received by the committee, and these submissions will be available to the Government when and should it review the firearms legislation. Those submissions will also be available to any other person wanting to view them. The time to put them together has not been wasted and will inform the Government in any review of the firearms legislation.

The media statement that will be released shortly after this statement reads -

The Select Committee inquiring into the Government's proposed firearms laws notes the announcement of 17 August 2018 that the Government would not be progressing the firearms law reforms as previously announced. As the Inquiry Terms of Reference were specifically drafted to address the Government's proposed reforms, the Committee has been placed in the unenviable position of being without valid Terms of Reference. The Committee is therefore unable to progress with the work of the Inquiry.

The Committee intends to table a report to this effect and will publish all public submissions as part of this, with the exception of those submissions indicated as confidential.

The Committee acknowledges the considerable thought and effort that went into the submissions and expresses its gratitude to all individuals and organisations that contributed to the Inquiry. The submissions will be available to assist the Government in the event that it reviews firearms policy in the future.
