Notices of Motion

- 181** The Minister for Veterans' Affairs to move—That the House:—
- (1) Recognises that 14 September 2019, is National Peacekeeper and Peacemaker Day, an annual day of remembrance for Australian military and police personnel who have served in peacekeeping operations across the globe.
 - (2) Notes that this day is the 72nd anniversary of the United Nations' first peacekeeping mission in 1947—an operation which consisted of four Australian military officers on the UN Good Offices Commission in the then Dutch East Indies, now known as Indonesia.
 - (3) Further notes that since this date, over 77,000 Australian defence and Police Force personnel have participated in at least 73 operations in 64 different countries.
 - (4) Commends our Tasmanian peacekeepers and their families for their service and the invaluable contribution they have made toward achieving peace in areas of need.
 - (5) Acknowledges the members of the Australian Peacekeepers and Peacemakers Veteran's Association – Tasmania Division.
 - (6) Pays tribute to the 16 Australians who have died on UN peacekeeping operations since 1948. (12 September 2019)
- 182** Ms *O'Connor* to move—That the House:—
- (1) Acknowledges on 20 September 2019 as part of a Global Climate Strike, over 15,000 people gathered on Parliament House Lawns in Hobart, with others striking around the State in Launceston, Devonport, Burnie, Wynyard, Zeehan, Currie and St Helens.
 - (2) Recognises there is widespread and growing public demand for climate action in the form of mass mobilisation and protest around the State, Country and the global community, with an estimated 150 million people taking part in the global climate strikes.
 - (3) Commits to standing by young people and the wider community in their fight for climate action and for their futures.
 - (4) Supports the global climate strike movement. (24 September 2019)
- 183** Mr *O'Byrne* to move—That the House:—
- (1) Notes the potential of the creation of hundreds of jobs in the establishment of a Hydrogen Industry in Tasmania.
 - (2) Recognises that a number of Asian countries, in particular Japan and South Korea are looking to Australia to provide Hydrogen energy to support them in their transition to Hydrogen.
 - (3) Acknowledges the work being done nationally, led by Chief Scientist, Alan Finkle in Charing the National Hydrogen Strategy Group, in the establishment of a National Hydrogen Strategy, due to be released by the end of 2019.

- (4) Further recognises the local community and industry leadership in the Tamar Valley advocating for the creation of this industry in Tasmania.
- (5) Further notes that the States of Queensland, Victoria, South Australia and Western Australia all have well established standalone State based strategies to maximise the economic opportunity for Hydrogen in their respective States.
- (6) Further notes that it is estimated that a hydrogen plant, converting renewable energy into hydrogen for export, would support the creation of 500 jobs in northern Tasmania.
- (7) Condemns the lack of action by the Hodgman Government on this opportunity and their failure to produce a strategy that would allow Tasmania to support the development of this new industry with the hundreds of jobs it would create. These are renewable and skilled jobs that are being squandered by the Hodgman Government because it doesn't have the vision or passion to make this potential billion dollar industry a reality for Tasmania. (24 September 2019)

184 The Minister for Primary Industries and Water to move—That the House:—

- (1) Recognises that 29 September 2019, is the 25th anniversary for Landcare Tasmania, the peak body working to represent, support, strengthen and grow Tasmania's community Landcare network.
- (2) Acknowledges that since 1994, Landcare Tasmania has been helping local groups care for Tasmania's unique environment and coasts and is the oldest state based Landcare organisation in Australia.
- (3) Notes that Landcare Tasmania now supports over 240 community Landcare groups across the State and approximately 4,400 regular members and volunteers who provide an incredible 135,000 hours of voluntary effort to help improve the health of our natural and working environments.
- (4) Further notes that the Hodgman Liberal Government's support of Landcare in Tasmania includes doubling funding to Landcare Tasmania to \$960,000 over four years and establishing a \$1.8 million Landcare Grants Program, delivered in partnership with the TFGA and Landcare Tasmania, to provide grants to farmers, Landcare and other community organisations for practical, on-ground works.
- (5) Further acknowledges that the first round of the Landcare Grants Program was announced on 31 August 2019 at Sillwood near Carrick, with more than \$200,000 provided in funding for 38 projects, attracting in kind contributions of around \$270,000—a tremendous example of the Government and community working together.
- (6) Further notes that Landcare Tasmania's 25th Anniversary Conference will be held from 25 – 27 October 2019, including the 2019 Landcare Awards Dinner on Saturday 26 October 2019 and the inaugural presentation of the Premier's Landcare Award.
- (7) Commends the staff at Landcare Tasmania, including CEO Rod Knight and Chair George Rance, for their hard work and efforts in promoting and supporting the Landcare movement across the State. (24 September 2019)

185 The Minister for Primary Industries and Water to move—That the House:—

- (1) Recognises that the 6th Longford Jazz Festival took place from 20 September to 22 September 2019.
- (2) Appreciates the Festival was a celebration of everything that is special and unique about jazz music, including an impressive range of performers from around the State and Country.
- (3) Acknowledges the 2019 Festival included a program of events celebrating key elements of jazz culture and music and included events around Perth and Longford, highlighted by a Saturday Night Jazz Concert at the Town Hall in Longford and traditional gospel service at Christchurch Longford on Sunday.
- (4) Commends the many performing artists and guest bands including St Patrick's School Band, Ross Challender's Little Big Band and Django Tiger involved with the Festival, which came from all around the State and beyond, showcasing their incredible talent.
- (5) Congratulates pianist Bruce Gourlay, recipient of the 2019 Peter Voss Memorial Award, and drummer Vicki Patterson, recipient of the 'Encouragement Award'.
- (6) Further congratulates Don Ives, for his leadership and vision to first start the music Festival in 2014, and Dee Alty for her commitment in helping organise the 2019 event.

- (7) Further congratulates all those involved for their hard work in promoting and putting on the Festival and also the Longford community on their efforts and commitment in again hosting what is a growing Festival each year. (24 September 2019)

- 186** The Minister for Corrections to move—That the House:—
- (1) Notes preliminary works have begun on the \$70 million Southern Remand Centre project at the Risdon Prison site.
 - (2) Further notes the contract for these works has been awarded to Tasmanian construction company the Hazell Brothers Group.
 - (3) Further notes that more than 130 jobs are expected to be created during construction of the 140-bed facility, with 50 ongoing jobs created upon completion.
 - (4) Further notes this major infrastructure project is part of the Hodgman majority Liberal Government's \$350 million prison infrastructure program to build capacity in the system and fix ageing infrastructure. (24 September 2019)

- 187** The Minister for Corrections to move—That the House:—
- (1) Welcomes support of the Hodgman majority Liberal Government's sensible remission reform.
 - (2) Acknowledges the policy backflip by the Labor Opposition, which previously strongly opposed remission reform then supported it days after the Labor spokesperson said they would not back it.
 - (3) Encourages Labor to perform a further backflip and support guaranteed jail time for child sex offenders and for violent criminals that assault our frontline workers including ambulance officers, child safety officers, correctional services officers and community corrections officers, nurses and midwives, and medical orderlies and hospital attendants.
 - (4) Notes that Labor still has no credibility on law and order and has no long-term plan to keep Tasmanians safe. (24 September 2019)

- 188** The Minister for Racing to move—That the House:—
- (1) Acknowledges the amazing results achieved by horses and participants in Tasmania's thoroughbred racing sector during racing season 2018/2019.
 - (2) Congratulates the winners of awards announced at the recent Tasmanian Thoroughbred Racing Awards.
 - (3) Notes the Hodgman Liberal Government's strong commitment to growing Tasmania's racing industry and the many social and economic benefits it provides to Tasmania. (24 September 2019)

- 189** The Minister for the Arts to move—That the House:—
- (1) Recognises that the long lists for the 2019 Premier's Literary Prizes have been announced.
 - (2) Notes that Danielle Wood, Richard Flanagan and Robbie Arnott are among many notable Tasmanian authors whose books have been long listed for these prizes.
 - (3) Further notes that the 2019 long lists, represents a remarkable range of interests, and is also a wonderful starting point for those who want to read some of the best work by Tasmanians, or about Tasmania.
 - (4) Acknowledges the Hodgman majority Liberal Government's support of the \$25,000 Tasmania Book Prize for the best book with Tasmanian content in any genre. (24 September 2019)

5 2019 Federal Election: Adjourned Debate on the Question proposed on Wednesday, 22 May 2019 by Mr *Shelton*—That the House:—

- (1) Congratulates Prime Minister Hon. Scott Morrison MP and the Federal Liberal Party for the outstanding result in the Australian Federal election held on 18 May 2019.
- (2) Further congratulates, subject to final confirmation, the election of Tasmanian Federal Liberal representatives in both the Senate and the House of Representatives.
- (3) Notes the strong relationship between the Hodgman and Morrison Governments, working together to deliver a stronger economy, real investment in infrastructure and better health and education services for all Tasmanians. (Next Speaker: Dr *Woodruff*)

6 Battery of the Nation: Adjourned Debate on the Question proposed on Wednesday, 31 July 2019 by Mrs *Rylah*—That the House:—

- (1) Notes Tasmania has the renewable and dispatchable energy the rest of the nation needs, and the Hodgman Liberal Government is committed to using this advantage to ensure all Tasmanians benefit.
- (2) Records this Governments continuing drive for the development of the Battery of the Nation and the crucial second interconnector, the Marinus project, which have the potential to inject up to \$5 billion into the Tasmanian economy and deliver 2,000 jobs, particularly into regional areas.
- (3) Further notes that the development stage of the first phase of the Battery of the Nation carries the commitment of the Federal Government through the Federal Underwriting New Generation Investment program.
- (4) Further notes that support by both the Hodgman Liberal Government and the Federal Government, gives UPC Renewables and AC energy, more confidence to develop their Robbins Island and Jims Plain wind and solar parks.
- (5) Recognises that Tasmania has a world-class wind resource complemented by our pumped hydro that means there will always be some electricity available for export when the mainland is experiencing low wind or high demand.
- (6) Acknowledges that the Australian Government clearly recognises the importance of Tasmania’s energy solutions and our status as the leading energy state.
- (7) Commends the Hodgman Liberal Government for its strong commitment to making use of the natural resources available to the State while at the same time ensuring all Tasmanians will have access to low cost, reliable and clean energy in their homes and businesses. (Mrs *Rylah*)

To which the following amendment has been proposed by Dr *Woodruff*, by leaving out all words after “That the House:-” and inserting instead:

- “(1) Notes that the Liberals repeatedly talk about the Marinus project and use it as a political wedge, particularly during election periods, despite the fact that they have not put forward a financing proposal or a position on who should finance the multi-billion project.
- (2) Agrees that the project could cost in excess of current total Public Non-Financial Corporations Sector debt, and feasibility studies and prominent economists such as Saul Eslake have raised serious concerns about the viability of the project, which have not been addressed by the State Government.
- (3) Notes that the Liberals passed legislation to set wholesale electricity prices at a rate higher than projected, leading to energy bills decreasing by less than they would otherwise would have.
- (4) Notes with alarm that the Liberal Government continues to allow Entura to engage in profiteering from immoral projects overseas such as the Karuma hydro power project Uganda, which has been linked to killings and other human rights violations.
- (5) Condemns the Liberal Government for their lack of honesty, ethics or plan in their handling of the Energy portfolio.” (Next Speaker: Minister for Energy)

7 Minimum Mandatory Sentences: Adjourned Debate on the Question proposed on Wednesday, 7 August 2019 by Mr *Tucker*—That the House:—

- (2) Further acknowledges that homelessness is often linked to other challenges such as mental illness, and the Tasmanian Government is focusing on the integration of mental health services to provide more holistic support and greater independence for clients.
- (3) Further acknowledges that Tasmania's Affordable Housing Strategy is responding to the current challenges in the housing market by boosting supply across a spectrum of needs.
- (4) Further acknowledges that the Affordable Housing Action Plan Stage 2 and the additional investment in funding is another positive step towards continuing this momentum.
- (5) Recognises that all levels of government have a role to play in addressing the supply and demand in our housing market.
- (6) Call on all Members to work together to put the needs of Tasmanians above political point scoring. (Next Speaker: Minister for Housing)
